AUTHORIZING THE EXECUTIVE OFFICER TO EXECUTE AN AGREEMENT BETWEEN THE STATE WATER RESOURCES CONTROL BOARD AND PLANNING AND RESEARCH ASSOCIATES, CONSULTANTS, TO PREPARE A REPORT CONCERNING THE SAN FRANCISCO BAY AREA

WHEREAS, Chapter 1232, Statutes of 1970, requires that this Board shall recommend to the Legislature alternate methods for implementing the water quality control system for the San Francisco Bay area not later than the fifth legislative day of the 1971 legislative session,


WHEREAS, personnel of Planning and Research Associates, Consultants, have been preparing some of the background material for this report and have a good understanding of the problems involved,

WHEREAS, there is a need for this expertise in preparing the material and developing the format of the final printed report;

NOW, THEREFORE, BE IT RESOLVED, that this Board authorize the Executive Officer to execute an agreement between the State Water Resources Control Board and Planning and Research Associates to provide necessary services to complete the report and prepare the necessary number of copies of the report for an amount not to exceed \$24,640.

Assembly Bill No. 480

CHAPTER 1232

An act relating to the San Francisco Bay Delta Study.

[Approved by Governor August 30, 1969. Filed with
Secretary of State August 31, 1969.]

The people of the State of California do enact as follows:

SECTION 1. The State Water Resources Control Board shall have authority to continue activities or make further studies of the type necessary to develop and expand the plan for a water quality control system as contained in the report submitted to the Legislature by the board pursuant to Chapter 1351, Statutes of 1965.

SEC. 2. The board shall recommend to the Legislature alternate methods for implementing the water quality control system not later than the fifth legislative day of the 1971 legislative session.

SEC. 3. The Legislature finds that it does not appear that a governmental entity will be created by the 1969 Legislature to implement the report submitted to the Legislature pursuant to Chapter 1351, Statutes of 1965. Therefore, in order to continue this planning effort on an interim basis until such time as a single or multipurpose entity or entities be established to plan, finance, construct and operate a comprehensive water pollution control plan for the study area, it is necessary for the Legislature to authorize continuation of activities and studies by the State Water Resources Control Board.
