STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 79-96

APPROVING AN AMENDMENT TO LOAN CONTRACT NO. WQL6-006-50 BETWEEN THE STATE WATER RESOURCES CONTROL BOARD AND THE HUMBOLDT BAY WASTEWATER AUTHORITY

WHEREAS:

- The Executive Director of the State Water Resources Control Board, pursuant to State Board Resolution No. 76-65, executed contract number WQL6-006-50 for a \$699,070 loan to the Humboldt Bay Wastewater Authority for construction of wastewater treatment facilities;
- Said loan contract, as amended pursuant to State Board Resolution No. 78-01, provided for repayment of the loan within 30 days of receipt of proceeds from the sale of the Authority's revenue bonds, or if the bonds were not sold, in four quarterly installments beginning October 10, 1979, and ending July 10, 1980;
- The Authority has not sold its revenue bonds, but has paid the first installment on October 9, 1979;
- 4. State Board Order No. WQ79-20 required construction of the Eureka crosstown interceptors and pump stations with award of all construction contracts by January 1, 1980, and completion by September 1, 1981. The Authority and its members are to complete additional facilities planning by October 1, 1980;
- 5. Sale of the Authority's revenue bonds could delay award of the construction contracts for the Eureka crosstown interceptors and pump stations; and,
- 6. Because the Authority and its members will not be able to finance construction of the interim improvements, facilities planning, and the loan repayment in 1980 without the sale of the Authority's revenue bonds, the Authority has requested that the loan contract be amended to provide for repayment of the remaining balance of the loan plus interest in four annual installments beginning October 10, 1980, and ending October 10, 1983.

THEREFORE, BE IT RESOLVED:

1. That the Executive Director of the State Water Resources Control Board be hereby authorized to execute an amendment to the State Board Contract WQL6-006-50, said amendment providing for repayment of the remaining balance of the loan plus interest in four annual installments beginning October 10, 1980, and ending October 10, 1983, and in a manner consistent with the attached repayment schedule, or if construction contracts for the Eureka crosstown interceptors and pump stations are not awarded by April 1, 1980, in a single installment payable by July 10, 1980; and,



- 2. That State Board Order No. WQ79-20 be amended to require advertisement of all construction contracts for the Eureka crosstown interceptors and pump stations by January 3, 1980, and award of all contracts by April 1, 1980; and,
- 3. That the Executive Director of the State Water Resources Control Board be hereby instructed to forward said amendment to the Director of Finance for approval.

AMENDMENT NO. 2 TO CONTRACT NO. WQL6-006-50 BETWEEN STATE WATER RESOURCES CONTROL BOARD AND HUMBOLDT BAY WASTEWATER AUTHORITY FOR A LOAN TO CONSTRUCT FACILITIES NECESSARY TO PREVENT WATER POLLUTION

IT IS HEREBY mutually agreed by and between the State of California, acting by and through the State Water Resources Control Board, hereinafter referred to as "Board", and the Humboldt Bay Wastewater Authority, hereinafter referred to as "Authority", that the contract executed on the 26th day of August 1976, for a loan from the Water Quality Control Fund is amended as follows:

1. Paragraph 13(b), Page 8, is amended to read,

"(b) If the Authority does not sell its bonds and repay the loan from the proceeds of the sale, the Authority shall make payments of principal and interest in accordance with the Second Amended Loan Repayment Schedule attached hereto and incorporated herein. The Authority may make payments of principal and interest in advance of the dates shown on the Second Amended Loan Repayment Schedule, in which event the final payment shall be adjusted so as to reflect any interest credits due the Authority by virtue of said advance payments of principal. However, in the event that the Authority has not awarded all contracts for the Eureka Crosstown interceptors by April 1, 1980, the remaining loan balance of \$591,723.06 plus interest to July 10, 1980, of \$23,478.15 will become due and payable on July 10, 1980."
