STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 80- 26

APPROVAL OF WORKPLANS FOR PHASE III 208 PLANNING

WHEREAS:

- 1. The U. S. Environmental Protection Agency (EPA) requested the State Board to provide EPA with California's recommendation on the allocation of F.Y. 1980 208 funds.
- EPA has indicated that approximately \$2,107,000 in federal 208 planning grant funds are available for California to conduct F.Y. 1980 208 planning.
- 3. The State Board and EPA have agreed that nine projects are eligible for 208 grant funding in F.Y. 1980.
- 4. Final workplans for the planning have been prepared for eight projects. Two of the projects will require \$130,667 in State matching funds, \$37,667 from State Clean Water Bond funds and \$93,000 from funding sources available to the State Department of Forestry.
- 5. The Board received public testimony on the preliminary workplans on November 21, 1979, and, in addition, agencies proposing projects provided opportunities for public participation prior to submitting their final workplans to the Board.
- 6. The Statewide Policy Advisory Committee reviewed the workplans for the nondesignated areas (San Joaquin River and North Coast Watershed Evaluation projects) and found that the workplans are generally acceptable.
- 7. The Board finds that conditional approval of the workplans for studies of the Upper Newport Bay and the North Coast Watershed Evaluation projects are necessary.

THEREFORE BE IT RESOLVED:

That the Board:

- 1. Approves the following workplans for water quality management planning:
 - a. San Lorenzo Watershed
 - b. San Joaquin River
 - c. Pajaro Groundwater
 - d. Oil and Grease Removal San Francisco Bay
 - e. Oxnard Plain Groundwater
 - f. San Francisco Bay Area Urban Runoff
- 2. Approves the workplan for the Upper Newport Bay in accordance with conditions contained in Exhibit A to Resolution No. 80-17.
- 3. Approves the North Coast Watershed Evaluation workplan contingent upon the addition of a task that specifies alternative best management practices to be imposed in critically erosive areas and recommends appropriate management agencies to implement the best management practices.

- 4. Authorizes the Executive Director to submit the workplans to EPA for approval, and
- 5. Authorizes the Executive Director to submit an application for and accept an EPA grant of approximately \$2,107,000.
