RESOLUTION NO. 85-12

CONSIDERATION OF A REVISION OF THE WATER QUALITY CONTROL PLAN FOR  
THE COLORADO RIVER BASIN REGION AND TRIENNIAL REVIEW AFFIRMATION

WHEREAS:


1. The California Regional Water Quality Control Board, Colorado River Basin Region, (Colorado River Basin Regional Board) adopted separate Water Quality Control Plans (basin plans) for the East Colorado River Basin (7A) and the East Colorado River Basin (7B) in April 10, 1975.
2. Subsequent to the April 10, 1975 adoptions, the Regional Board made several revisions to both (7A and 7B) basin plans.
3. In order to review the basin plans for the West and East Colorado River Basin, the Colorado River Basin Regional Board, after properly notifying all interested parties, conducted public hearings on July 13 and November 16, 1983. After evaluating and considering all testimony, the Colorado River Basin Regional Board adopted Resolution NO. 84-68 on May 16, 1984 revising and combining the West (7A) and East (7B) Colorado River Basin Plans into a single plan document for the entire Colorado River Basin Region.
4. On May 21, 1984, the Colorado River Basin Regional Board received further comments from the U. S. Environmental Protection Agency, Region 9, (EPA) which were subsequently resolved through meetings and correspondence between Colorado River Basin Regional Board, EPA, and State Board staff.
5. On November 14, 1984, after due notice to all interested parties, the Colorado River Basin Regional Board adopted the modifications to the revised basin plan in Resolution No. 84-121.
6. The basin plan review and modifications adopted by Colorado River Basin Regional Board Resolution Nos. 84-68 and 84-121 constitute compliance with the triennial review process as specified by Section 303(c)(1) of the Clean Water Act.
7. Basin plan amendments do not become effective until approved by the State Board.

THEREFORE BE IT RESOLVED:

1. That the Colorado River Basin Regional Board Resolution Nos. 84-68 and 84-121 revising and updating the basin plan for the Colorado River Basin Region are approved.
2. That the State Board directs the Executive Director to submit the revised basin plan for the Colorado River Basin Region to EPA requesting approval of completion of the triennial review to the water quality standards for the Colorado River Basin.
