STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 85-72

APPROVAL OF THE ECOLOGY AND ENVIRONMENT, INCORPORATED, AND THE LUHDORFF AND SCALMANINI CONSULTING ENGINEERS' FINAL DRAFT REPORTS AS COMPLETION OF THE NIMBUS AREA GROUND WATER INVESTIGATION STUDY

WHEREAS:

- 1. Pursuant to the terms of a first-cycle federal 205(j) grant from the U. S. Environmental Protection Agency (EPA), the State Water Resources Control Board (State Board) provided funds to the California Regional Water Quality Control Board, Central Valley Region (Central Valley Regional Board) to conduct the Nimbus Area Ground Water Investigation Study.
- 2. The Central Valley Regional Board contracted with Ecology and Environment, Incorporated, and Luhdorff and Scalmanini Consulting Engineers to perform the technical work.
- 3. The final draft reports entitled "Soil Contamination Investigation of Purity Oil Sales--Sacramento and the Davies Property in Rancho Cordova, California" and "Well Testing, Ground Water Sampling and Monitoring Well Construction-- Eastern Sacramento County" were submitted by Ecology and Environment, Incorporated, and Luhdorff and Scalmanini Consulting Engineers, respectively, to the Central Valley Regional Board.
- 4. The Central Valley Regional Board's Executive Officer, under authority delegated by the Central Valley Regional Board, has accepted the work contained in the above final draft reports as required in the contracts and has forwarded them to the State Board as completion of the Nimbus Area Ground Water Investigation Study.
- 5. The State Board finds that the work contained in the final draft reports prepared by Ecology and Environment, Incorporated and Luhdorff and Scalmanini Consulting Engineers conform to the requirements of the EPA 205(j) grant and the contracts under which the work was funded and that the Central Valley Regional Board has satisfactorily completed the 205(j) Nimbus Area Ground Water Investigation Study.

THEREFORE BE IT RESOLVED:

That the State Board:

- 1. Accepts the work contained in the Ecology and Environment, Incorporated, and Luhdorff and Scalmanini Consulting Engineers' final draft reports as completion of the contracts under which the work was funded.
- Authorizes final payment to Ecology and Environment, Incorporated, and Luhdorff and Scalmanini Consulting Engineers.
- 3. Directs staff to transmit the final draft reports to EPA as completion of the 205(j) Nimbus Area Ground Water Investigation Study.
