STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 86-6

ACCEPTANCE OF THE 205(j) FINAL REPORTS ENTITLED
"THE LONG-TERM MONITORING OF PHYTOPLANKTON, ZOOPLANKTON,
AND PRIMARY PRODUCTION IN SAN FRANCISCO BAY" AND "SAMPLING
SYSTEM FOR DRIFT ALGAE IN SAN FRANCISCO BAY"

WHEREAS:

- 1. Pursuant to the terms of a Phase I Section 205(j) grant (Clean Water Act 33 USCA 1285) from the U. S. Environmental Protection Agency (EPA), the State Water Resources Control Board (State Board) provided funds to the California Regional Water Quality Control Board, San Francisco Bay Region (San Francisco Bay Regional Board) to develop:
 - a. a primary productivity measuring technique,
 - b. sampling conditions for monitoring plankton, and
 - c. a macrophyte (seaweed) sampling protocol.
- 2. The San Francisco Bay Regional Board staff has reviewed, accepted, and submitted to the State Board the 205(j) final reports entitled "The Long-Term Monitoring of Phytoplankton, Zooplankton, and Primary Production in San Francisco Bay" and "Sampling System for Drift Algae in San Francisco Bay".
- 3. The State Board has found that the aforementioned final reports conform to the requirements of the EPA 205(j) grant and fulfill the San Francisco Bay Regional Board's project workplan entitled "Preliminary Studies Needed for the 'Plan for Assessing the Effects of Pollutants in the San Francisco Bay-Delta Estuary'".
- 4. The State Board has found that the aforementioned final reports fulfill the requirements of the contracts with the University of California, Berkeley, (No. 3-008-433-1) and San Francisco State University (No. 3-009-433-1).

THEREFORE BE IT RESOLVED:

That the State Board:

- Accepts the aforementioned final reports as fulfillment of the San Francisco Bay Regional Board's 205(j) project workplan.
- Accepts the aforementioned final reports as completion of the contracts with the University of California, Berkeley, (No. 3-008-433-1) and San Francisco State University (No. 3-009-433-1).

3. Directs staff to transmit the final reports to EPA as completion of the San Francisco Bay Regional Board's 205(j) project entitled "Preliminary Studies Needed for the 'Plan for Assessing the Effects of Pollutants in the San Francisco Bay-Delta Estuary'".
