STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 89-65

ACCEPTANCE OF THE "REVISED WORKPLAN FOR THE PROCEEDINGS ON THE SAN FRANCISCO BAY/SACRAMENTO-SAN JOAQUIN DELTA ESTUARY"

WHEREAS:

- 1. The State Board is conducting proceedings (Bay-Delta Proceedings) to consider revising the standards contained in the existing Water Quality Control Plan for the Sacramento-San Joaquin Delta and Suisun Marsh (Delta Plan) and in Water Right Decision 1485, both of which were adopted in August 1978. In the Bay-Delta Proceedings the Board will consider requirements including salinity, flow temperature and pollutants for the waters of the San Francisco Bay/Sacramento-San Joaquin Delta Estuary and the means of implementing such requirements.
- 2. The Bay-Delta Proceedings include a triennial review under Section 303(c) of the Federal Clean Water Act of the water quality standards in the Delta Plan.
- 3. On February 5, 1987, the State Board adopted Resolution No. 87-7, adopting a "Workplan for the Hearing Process on the San Francisco Bay/Sacramento-San Joaquin Delta Estuary"; because of necessary changes in the Bay-Delta Proceedings, the February 5, 1987 workplan must be revised.
- 4. The Revised Workplan for the Proceedings on the San Francisco Bay/Sacramento-San Joaquin Delta Estuary (Revised Workplan) is aimed at meeting the State Board's goal of completing the Bay-Delta Proceedings by the middle of 1993.
- 5. The Revised Workplan describes the scope, goals, and schedule of the Bay-Delta Proceedings.
- 6. We anticipate that future modifications of the Revised Workplan will be necessary from time to time in order accurately to describe the proceedings. Future modifications can most efficiently be accomplished administratively rather than through Board adoption of the modifications.

THEREFORE BE IT RESOLVED:

1. That the State Water Resources Control Board accepts the "Revised Workplan for the Proceedings on the San Francisco Bay/Sacramento-San Joaquin Delta Estuary" dated July 20, 1989.

- 2. That the State Water Resources Control Board directs the Chief of the Division of Water Rights to modify the Revised Workplan as necessary in the future, after public participation, and to notify the parties in the Bay-Delta Proceedings of the modifications.
- 3. That the State Water Resources Control Board revokes Resolution No. 87-7, in which the Board adopted the Workplan for the Hearing Process on the San Francisco Bay/Sacramento-San Joaquin Delta Estuary dated February 5, 1987.
