ACCEPTANCE OF THE U.S. GEOLOGICAL SURVEY'S INTERIM REPORT AND THE CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD, LAHONTAN REGION'S JULY 28, 1989 SUBMITTAL AS COMPLETION OF THE PHASE III 205(j)(2) "TRANSPORT OF CONTAMINANTS FROM UNDERGROUND WASTEWATER DISPOSAL SYSTEMS, UPPER MOJAVE RIVER BASIN, CALIFORNIA" PROJECT

WHEREAS:

- 1. Pursuant to the terms of a Phase III 205(j)(2) grant from the U.S. Environmental Protection Agency (EPA), the State Water Resources Control Board (State Board) provided funds to the California Regional Water Quality Control Board, Lahontan Region (Lahontan Regional Board) to conduct a project entitled "Transport of Contaminants from Underground Wastewater Disposal Systems, Upper Mojave River Basin, California" Project (Project).
- The Lahontan Regional Board entered into a joint-funding agreement with the U.S. Geological Survey (USGS) to conduct the first year of the three-year study.
- 3. The Lahontan Regional Board staff has accepted and transmitted the USGS's Transport of Contaminants from Underground Wastewater Disposal Systems, Upper Mojave River Basin, California: Interim Report (Interim Report) as a product of their joint-funding agreement.
- The Lahontan Regional Board staff has submitted supplemental information on July 28, 1989.
- 5. The State Board finds that the Interim Report and supplemental material submitted by the Lahontan Regional Board on July 28, 1989 satisfy the requirements of the EPA Phase III 205(j)(2) grant and workplan.

THEREFORE BE IT RESOLVED:

That the State Board:

 Accepts the Interim Report and the Lahontan Regional Board's July 28, 1989 submittal as completion of the Lahontan Regional Board's Phase III 205(j)(2) Project. Directs State Board staff to transmit the Interim Report and the Lahontan Regional Board's July 28, 1989 submittal to EPA as completion of the Lahontan Regional Board's "Transport of Contaminants from Underground Wastewater Disposal Systems, Upper Mojave River Basin, California" Phase III 205(j)(2) Project.
