## STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 90-81

APPROVAL OF AN AMENDMENT TO THE COMPREHENSIVE WATER QUALITY CONTROL PLAN FOR THE SAN DIEGO BASIN REVISING GROUND WATER BENEFICIAL USE DESIGNATIONS AND WATER QUALITY OBJECTIVES FOR A PORTION OF THE SAN CLEMENTE HYDROLOGIC AREA

## WHEREAS:

- 1. The California Regional Water Quality Control Board, San Diego Region (San Diego Regional Board) adopted the Comprehensive Water Quality Control Plan for the San Diego Basin (Basin Plan) on March 17, 1975.
- 2. Section 13240 of the California Water Code specifies that basin plans be periodically reviewed and, if appropriate, revised.
- 3. The San Diego Regional Board staff prepared documents and followed procedures satisfying environmental documentation requirements in accordance with the California Environmental Quality Act.
- 4. On March 12, 1990, following a public hearing, the San Diego Regional Board adopted Resolution No. 90-28 (Attachment 1) which amended the Basin Plan by deleting all beneficial use designations and water quality objectives for ground water in the Segunda Descheca Canada drainage east of the easterly right-of-way of Interstate 5, a portion of the San Clemente Hydrologic Area (HA 901.30) (Attachment 2).
- 5. The State Water Resources Control Board (State Board), after reviewing the Basin Plan Amendment, supporting documents provided by the San Diego Regional Board, and other available information, finds that there is sufficient evidence to show that the proposed amendments comply with the requirements of State Board Resolution No. 68-16 and the exceptions to State Board Resolution No. 88-63 (Sources of Drinking Water Policy) as amended into the Basin Plan.
- 6. San Diego Regional Board Resolution No. 90-28 pertains to ground water beneficial uses and water quality objectives only and need not be approved by the U.S. Environmental Protection Agency under the Federal Clean Water Act.
- 7. Section 13245 of the California Water Code specifies that a revision of a water quality control plan adopted by a Regional Water Quality Control Board does not become effective until approved by the State Board.

## THEREFORE BE IT RESOLVED:

That the State Board approves San Diego Regional Board Resolution No. 90-28 amending the Comprehensive Water Quality Control Plan for the San Diego Basin by deleting all beneficial use designations and water quality objectives for ground waters in the Segunda Descheca Canada drainage (San Clemente Hydrologic Area) east of the easterly boundary of the right-of-way of Interstate 5.
