RESOLUTION NO. 90-96

ADOPTION OF THE FFY 1991 STATE REVOLVING FUND  
(SRF) LOAN PROGRAM PRIORITY LIST  
AND  
INTENDED USE PLAN (IUP)

WHEREAS:

1. The Division of Loans and Grants has proposed a FFY 1991 SRF Loan Program Priority List based on Regional Board and public input consistent with the federal Clean Water Act;
2. The availability of funds under the SRF program and the interest expressed for developing future water supplies support the expansion of the fundable portion of the FFY 1991 Priority List;
3. The federal Clean Water Act allows the states to set aside up to 20 percent of their federal Capitalization Grant to fund major sewer system rehabilitation (Needs Category IIIB), new collection sewers (Needs Category IVA), and combined sewer overflow correction (Needs Category V) projects and nonpoint source, storm drainage pollution, and estuary enhancement programs and projects.
4. The State Board established a \$40 million cap on projects in FFY 1989 and FFY 1990 and the need exists to continue a cap for a portion of FFY 1991 to assure a reasonable distribution of the available funds;
5. Section 601(a) of the federal Clean Water Act authorizes loans for developing and implementing nonpoint source, storm drainage pollution and estuary enhancement programs and projects;
6. The federal Clean Water Act allows the states to reserve four percent of their annual SRF allotment for loan administration; and
7. The federal Clean Water Act, as amended (33 U.S.C. Sec. 1251 et seq.) requires submittal of an IUP as part of a state's application for a Capitalization Grant.


THEREFORE BE IT RESOLVED THAT THE STATE BOARD:

1. Approves the addition of Priority Class D reclamation projects to the fundable portion of the FFY 1991 Priority List;
2. Approves the set-aside of up to 20 percent of the FFY 1991 Capitalization Grant for construction of new collection systems and combined sewer overflow correction projects;
3. Approves the continuation of the \$40 million funding limit on the amount of federal funds that any one agency can receive from FFY 1991 up to April 1, 1991. After this date, all projects can compete on a first-come first-served basis for any remaining funds;

4. Approves a minimum reserve of \$5 million in FFY 1991 for issuance of loans for nonpoint source, storm drainage pollution and estuary enhancement activities;
5. Approves the set-aside of four percent of the FFY 1991 Capitalization Grant amount for SRF loan administration; and
6. Adopts the FFY 1991 SRF Loan Program Priority List and IUP.
