RESOLUTION NO. 92-41

ADOPTION OF WATER QUALITY ASSESSMENT INCORPORATING
FEDERAL CLEAN WATER ACT SECTION 303(d)
304(1), 314, AND 319 LISTS AND 40 CODE OF
FEDERAL REGULATIONS, SECTION 131.11

WHEREAS:


1. The State Water Resources Control Board (State Water Board) uses the Clean Water Strategy to assist in prioritizing water quality activities.
2. The Water Quality Assessment provides information necessary for the development of the Clean Water Strategy.
3. The Water Quality Assessment has been compiled from the nine Regional Water Quality Assessments adopted by the respective California Regional Water Quality Control Boards (Regional Water Boards).
4. The Water Quality Assessment includes the Clean Water Act (CWA) Sections 303(d), 304(1), 314, and 319 lists for the State of California.

THEREFORE BE IT RESOLVED:

1. That the 1992 update of the State of California's Water Quality Assessment is approved, including the lists for Sections 303(d), 304(1), 314, and 319 of the CWA that are incorporated therein.
2. That the Executive Director is authorized to transmit the lists for Sections 303(d), 304(1), 314, and 319 of the CWA to the U.S. Environmental Protection Agency to satisfy the requirements of that Act.
3. That the 1992 update of the Water Quality Assessment is complete.
4. That the State Water Board may review the lists for Sections 303(d), 304(1), 314, and 319 of the CWA once the Clean Water Strategy development is complete and the State Water Board's priorities are made clear.
