STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 92-86

APPROVAL OF REALLOCATION OF STATE REVOLVING FUND LOAN FROM SUNNYDALE TRANSPORT AND STORAGE PROJECT TO OCEANSIDE WATER POLLUTION CONTROL PLANT PROJECT, CITY AND COUNTY OF SAN FRANCISCO

WHEREAS:

- 1. The State Water Board, on August 18, 1988, adopted the "Policy for Implementing the State Revolving Fund (SRF) for Construction of Wastewater Treatment Facilities", and amended it on September 20, 1990;
- 2. The State Water Board, on September 26, 1991, adopted the FFY 1992 SRF Loan Program Priority List which includes the Oceanside Water Pollution Control Plant project as scheduled for FFY 1992;
- 3. The State Water Board approved \$4.1 million of SRF Loan for the construction of Sunnydale Transport and Storage project on October 24, 1991. The City and County of San Francisco has not been able to spent the approved funding on Sunnydale Transport and Storage project due to unforeseen complications and is requesting reallocation of the approved funding to Oceanside Water Pollution Control Plant project;
- 4. The State Water Board approved \$112.2 million of SRF loans (\$40 million on April 20, 1989, \$30 million on October 19, 1989, and \$42.2 million on September 20, 1990) for the construction of Oceanside Water Pollution Control Plant:
- 5. The Division of Clean Water Programs has approved the project report, and the draft revenue program for the construction of Oceanside Water Pollution Control Plant; and
- 6. The information contained in the EIR (State Clearing house No. 86120209) prepared for Oceanside Water Pollution Control Plant project, has been reviewed and considered, and it has been determined that:
 - (a) Changes or alterations have been required in, or incorporated into, the project which avoid or substantially lessen the potentially significant environmental impacts identified in the EIR with respect to the following aspects of the project: (i) water quality impacts will be mitigated by using permeable pavement materials to decrease runoff, designing the plant to allow drainage of water to deeper soils or to the plant, and using wells to monitor saltwater intrusion into groundwater due to construction dewatering; and (ii) impacts to cultural resources will be mitigated by stopping construction when previously unidentified resources are encountered and using a qualified archeologist to evaluate and report the site.

(b) With respect to the other potentially significant environmental impacts identified in the EIR, appropriate changes or alterations are within the responsibility and jurisdiction of other public agencies and such other changes or alternations have been adopted or can and should be adopted by such other agencies.

THEREFORE BE IT RESOLVED THAT:

The State Water Board approves reallocation of \$4.1 million SRF loan from Sunnydale Transport and Storage project to Oceanside Water Pollution Control Plant project, City and County of San Francisco, with the same conditions for repayment (a repayment period of twenty (20) years, and the first repayment to be due one (1) year after the first loan disbursement).
