AMENDMENT OF THE INITIAL UNDERGROUND STORAGE TANK (UST)
CLEANUP FUND PRIORITY LIST

WHEREAS:


1. The Health and Safety Code authorizes the State Water Board to expend money from the UST Cleanup Fund for payment of claims against the Fund;
2. The Health and Safety Code requires the State Water Board to pay claims in accordance with a four-class priority ranking system and requires the State Water Board to adopt a priority ranking list at least twice annually;
3. The State Water Board adopted the Initial UST Cleanup Fund Priority List on July 16, 1992, and amended the list on September 17, 1992;
4. The Division of Clean Water Programs continues to make decisions on appeals regarding placement on the priority list; and
5. Some claimants may be delayed or otherwise harmed because a decision on their appeal was not made prior to adoption of the Initial Priority List.

THEREFORE BE IT RESOLVED THAT:

The State Water Board amends the Initial UST Cleanup Fund Priority List dated July 16, 1992 to add the 166 claims shown in Attachment 1 which, as the result of an appeal, have been determined to be eligible for placement on the list.
