RESOLUTION NO. 94-40

APPROVING THE CIRCLE K CORPORATION SETTLEMENT FUND
PRIORITY LIST

WHEREAS:

1. Through bankruptcy proceedings, Circle K Corporation has abandoned numerous petroleum underground storage tank (UST) sites in California and many of the USTs have leaked petroleum into the soil and groundwater;
2. Under a settlement agreement executed between the State Water Resources Control Board (SWRCB) and Circle K Corporation (effective July 26, 1993), California was awarded approximately \$3.9 million, to be provided in seven annual payments, to pay landlords and other persons for costs associated with tank removal and cleanup at designated sites;
3. Section 25299.50 of Article 6 of Chapter 6.75, Division 20, California Health and Safety Code authorizes the SWRCB to create accounts within the Underground Storage Tank Cleanup Fund (USTCF);
4. The SWRCB has established procedures (Water Quality APM Chapter 20) for administering the Circle K Settlement Fund, which was created by virtue of the SWRCB's authority expressed in Section 25299.50;
5. Claim application forms were mailed to all identified interested parties on December 30, 1993, with a February 15, 1994 submittal deadline to be considered for inclusion on the first priority list;
6. The Division of Clean Water Programs received 103 applications by the specified deadline. Four claims were rejected, and 99 claims were accepted and recommended for placement on the priority list;
7. Claims were assigned random numbers to establish their relative rank on the list;
8. It is estimated that approximately: \$410,000 is available for claim payments for Fiscal Year (FY) 1993/94; \$510,000 for FY 1994/95; and \$520,000 for FY 1995/96. This is sufficient funding to pay all claims included on the initial priority list.

THEREFORE BE IT RESOLVED THAT:

The State Water Board hereby approves the Circle K Priority List and authorizes the Division of Clean Water Programs to process and pay claims in priority order based on current available funds and future expected allotments.
