STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 94-114

APPROVAL OF THE FEDERAL CLEAN WATER ACT SECTION 314 CLEAN LAKES PROGRAM GRANTS

WHEREAS:

- 1. The State Water Resources Control Board (SWRCB) is the State agency authorized to administer the federal Clean Lakes Program under Section 314 of the Clean Water Act;
- 2. The U.S. Environmental Protection Agency (EPA) has allocated Federal Fiscal Year (FFY) 1995 funds for expenditure in EPA, Region 9 for implementing projects to protect and restore publicly owned freshwater lakes;
- 3. The SWRCB has been requested by EPA to submit completed applications for Clean Lakes Program funds for their competitive evaluation. Applicants for project funding must provide a minimum of 30 percent matching nonfederal funds for each diagnostic (Phase I) project, and 50 percent match for each implementation (Phase II) and lake water quality assessment projects;
- 4. EPA, Region 9 is anticipated to issue award notices during July 1995, and the SWRCB must accept any grant award within 21 days of its offer.

THEREFORE BE IT RESOLVED THAT:

The State Water Resources Control Board:

- 1. Establishes and recommends to EPA the attached priority list for funding proposed Clean Lakes Program projects.
- 2. Authorizes the Executive Director, or his designee, to apply for FFY 1995 Clean Lakes grants and to accept any grant award offered by EPA, Region 9.
- 3. Authorizes the Executive Director, or his designee, to negotiate and execute all contracts and amendments necessary to carry out the approved projects.
