STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 95-58

ADOPTION OF THE FEDERAL FISCAL YEAR 1996 STATE REVOLVING FUND (SRF) LOAN PROGRAM PROJOECT PRIORITY LIST

WHEREAS:

- 1. The Division of Clean Water Programs (Division) has developed the FFY 1996 SRF Loan Program Priority List based on Regional Board and public input consistent with the Federal Clean Water Act;
- 2. The availability of funds under the SRF Loan program and the interest expressed for developing and implementing nonpoint source, water reclamation, storm drainage pollution, and estuary enhancement programs and projects support funding Priority Classes A through D in FFY 1996;
- 3. It is expected that the FFY 1996 appropriations bill will allow the States to fund major sewer system rehabilitation (Needs Category IIIB), new collection system (Needs Category IVA), and combined sewer overflow projects (Needs Category V) projects without limitation;
- 4. The SWRCB has historically deferred funding for major sewer system rehabilitation;
- 5. A need exists to continue the cap for FFY 1996 to assure a reasonable distribution of the available funds, and the Division has proposed a sliding scale for the FFY 1996 cap based on various levels of federal and State funding;
- 6. Up to 4 percent of the FFY 1996 federal Capitalization Grant is available for state administration.

THEREFORE BE IT RESOLVED THAT:

The State Water Resources Control Board:

- Approves the placement of Priority Classes A through D on the fundable portion of the FFY 1996 Priority List;
- 2. Approves funding in FFY 1996 for new collection system and combined sewer overflow projects and defers funding for major sewer rehabilitation projects for FFY 1996 and directs that funding for major sewer rehabilitation projects be deferred and the projects placed on the unscheduled portion of the list;

- 3. Authorizes the Division of Clean Water Programs to set the funding cap of between \$5 million to \$50 million (the amount of funds that any one agency can receive from FFY 1996 funds) depending on the level of funding available in FFY 1996;
- 4. Approves the set-aside of four percent of the FFY 1996 Capitalization Grant amount for SRF Loan Program administration;
- 5. Adopts the final FFY 1996 SRF Loan Program Project Priority List.
