STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 95-60

APPROVAL OF A STATE REVOLVING FUND LOAN FOR THE CITY OF CORONA, WASTEWATER TREATMENT PLANT NO. 1 EXPANSION PROJECT STATE REVOLVING FUND LOAN PROJECT NO. C-06-4461-110

WHEREAS:

- 1. The State Water Resources Control Board, on February 16, 1995, adopted the "Policy for Implementing the State Revolving Fund for Construction of Wastewater Treatment Facilities" (SRF Policy);
- 2. In accordance with the SRF Policy, Section IV(C), the SWRCB may modify its priority list at any time to include new projects;
- 3. The Division of Clean Water Programs has approved the project report, environmental documents, draft revenue program, and water conservation plan, for the City's Wastewater Treatment Plant No. 1 Expansion Project; and
- 4. The City of Corona certified an Environmental Impact Report (State Clearinghouse No. 90020909) which has been reviewed and considered, and it has been determined that:
 - (a) Changes or alterations which have been required in, or incorporated into the proposed project which avoid or reduce to less than significant levels, the potentially significant environmental effects identified in the EIR with respect to:

 (i) water quality impacts which will be mitigated by using a complete and approved grading plan to avoid siltation, and by using a properly sized emergency generator to prevent inadequately treated wastewater due to power failure; and (ii) cultural resources impacts which will be mitigated by using an archeological monitor and avoiding the bluff on which the CA-REV-1044 site is located.
 - (b) With respect to other potentially significant environmental impacts identified in the environmental documents, appropriate changes or alterations are not within the responsibility and jurisdiction of the SWRCB. Such other changes or alterations have been adopted or should be adopted by other agencies.

THEREFORE BE IT RESOLVED THAT:

THE STATE WATER RESOURCES CONTROL BOARD:

- 1. Places the City of Corona on the fundable portion of the FFY 1995 Priority List and approves a SRF loan of \$15 million to the City of Corona for construction of the Wastewater Treatment Plant No. Expansion Project, with a repayment period of twenty (20) years, and the first repayment due one (1) year after completion of construction; and
- 2. Will withdraw this \$15 million preliminary SRF loan approval if biddable plans and specifications are not approved by the Division of Clean Water Programs by July 1, 1996. The Division may approve up to a ninety (90) day extension for a good cause.
