NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) staff will hold public stakeholder outreach workshops to discuss the proposed statewide general waste discharge requirements for winery process water treatment systems (Winery General Order). Attendees will have the opportunity to discuss the proposed Winery General Order. The workshops will be informal staff-level stakeholder events. Additional workshops may be scheduled in other wine-making areas of the state. However, the agenda and information presented will be the same for all workshops. Some State Water Board members may attend the meetings; if a quorum of the State Water Board is present, no formal action will be taken.

BACKGROUND

The State Water Board is developing a Winery General Order that addresses land discharge of process water from wineries, grape juice storage facilities, and wine distillation facilities (hereafter collectively referred to as wineries). The Winery General Order will be applicable statewide and is intended to streamline and improve permitting consistency.

WORKSHOP PURPOSE

As part of the development process, State Water Board staff has scheduled public outreach workshops. An administrative draft of the Winery General Order was transmitted on February 11, 2019; informal comments were due April 5, 2019. There will be an opportunity to provide written comments during the formal comment period when the Winery General Order is transmitted for formal public comment.


