# NOTICE OF CONSIDERATION OF APPROVAL OF AMENDMENTS TO THE WATER QUALITY CONTROL PLAN FOR THE CENTRAL COASTAL BASIN TO IMPROVE AND CLARIFY WASTE DISCHARGE PROHIBITION LANGUAGE

**NOTICE IS HEREBY GIVEN** that the State Water Resources Control Board (State Water Board) will consider adopting a resolution approving the California Regional Water Quality Control Board, Central Coast Region's (Central Coast Water Board) amendments to the Water Quality Control Plan for the Central Coastal Basin (Basin Plan) to improve and clarify waste discharge prohibition language (Basin Plan amendment). The Central Coast Water Board adopted the Basin Plan amendment on February 18, 2022 (Resolution No. R3-2022-0001).
