# NOTICE OF (1) OPPORTUNITY TO ADD TO THE PUBLIC RECORD, (2) OPPORTUNITY TO COMMENT, AND (3) PUBLIC WORKSHOP ON AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE SAN DIEGO REGION TO INCORPORATE A BIOLOGICAL OBJECTIVE

On September 6, 2024, the State Water Resources Control Board (State Water Board) provided public notice that it was postponing a September 18, 2024 public meeting to consider approval of an amendment to the Water Quality Control Plan for the San Diego Basin to incorporate a water quality objective for biological condition adopted by the San Diego Regional Water Quality Control Board (San Diego Water Board) on December 8, 2020 ("Basin Plan Amendment," see Resolution No. R9-2020-0234). The notice informed the public that the State Water Board would hold a public workshop to further consider issues and would subsequently identify the date and issues.

Prior to holding the public workshop, the State Water Board will:

- 1. Reopen the administrative record to accept new evidence, limited to the subject outlined below,
- 2. Provide a summary of the new evidence that it is accepting into the record, and
- 3. Open a public comment period on that evidence.

## OPPORTUNITY TO ADD TO THE ADMINISTRATIVE RECORD

**NOTICE IS HEREBY GIVEN** that the State Water Board is reopening the administrative record to accept new evidence (e.g., California Stream Condition Index data) published since November 18, 2020 (the date the San Diego Water Board's hearing, at which oral comments on the full amendment were accepted) that is relevant to the use of the proposed biological objective in anthropogenically and physically modified soft-bottom streams in the San Diego Region. Data from outside the region will only be accepted and considered if it is demonstrated to be applicable to use of the CSCI within the San Diego region. New evidence must be accompanied by a statement of the relevance of the evidence to the implementation of the proposed biological objective.

In order to be considered, all new evidence must be received by **12:00 noon on Monday**, February **24**, **2025**.

**NOTICE IS HEREBY GIVEN** that the State Water Board is seeking written public comments on the new evidence accepted into the administrative record from **April 1, 2025, until 12:00 noon on Monday, May 19, 2025**. Comments that are not directly related to the new evidence will not be accepted. Comments received after that deadline will not be accepted unless the State Water Board determines otherwise.

The State Water Board will not reconsider comments already received or consider any new comment that it determines is not directly relevant to new evidence added to the administrative record.

### **PUBLIC WORKSHOP**

**NOTICE IS HEREBY GIVEN** that the State Water Board will hold a public workshop on May 6, 2025, on the following limited topics:

- New evidence (e.g., California Stream Condition Index data) accepted by the State Water Board that is relevant the use of the proposed biological objective in anthropogenically and physically modified soft-bottom streams in the San Diego Region. Data from outside the region will only be accepted and considered if it is demonstrated to be applicable to use of the CSCI within the San Diego region. New evidence must be accompanied by a statement of the relevance of the evidence to the implementation of the proposed biological objective.
- How the San Diego Water Board intends to implement the Basin Plan amendment for modified, soft-bottom streams.

Although a quorum of the Board is expected to be present at the workshop, the State Water Board will not take any formal action. The workshop is an opportunity for staff and interested persons to provide oral comments to the State Water Board Members. The Board Members may provide direction to staff, but no final action will be taken until a subsequent, noticed Board meeting.

### **BACKGROUND**

The San Diego Water Board adopted the Basin Plan Amendment and approved a Substitute Environmental Document on December 8, 2020, by Resolution No. R9-2020-0234. The Basin Plan Amendment adds a biological objective for streams, with specific exceptions, using the California Stream Condition Index. The Basin Plan Amendment also includes a program of implementation to integrate the biological objective into the San Diego Water Board's regulatory programs and to guide development of future biological objectives.
