### NOTICE OF SPECIAL MEETINGS IN CLOSED SESSION

The State Water Resources Control Board (State Water Board or Board) may meet on July 14, 2026, beginning at 9:00 a.m. at the CalEPA Building, Conference Room 2510. July 23, and July 29, 2026, beginning at 9:00 a.m. at the CalEPA Building, Conference Room 2540, 1001 I Street, Sacramento, California.

The meetings will consist of a closed session to deliberate on procedural or substantive decisions in the following proceedings:

- The water right change petition filed by the California Department of Water Resources to add two new points of diversion and redirection to water right permits 16478, 16479, 16481, and 16482 (Applications 5630, 14443, 14445A, and 17512, respectively) for the State Water Project associated with the Delta Conveyance Project.
- The petition for partial assignment of state-filed Application 25517, accompanying water right Application 25517X01, and petitions for release from priority of state-filed Applications 25513, 25514, 25517 (unassigned portion), 22235, 23780, and 23781 in favor of water right Application 25517X01 filed by the Sites Project Authority.
