Mr. Hoch:

We are writing in response to your letter dated January 12, 2005, which we received on January 19, 2005. We believe that the vast majority of the specified documents that exist are contained in hard files that are available for your review. The one major exception is photo documents, all of which are digital and very few exist in a printed format. However, we are prepared to provide you with a compact disc (CD) containing all related photos. Because it is possible that some of the requested written documents are in electronic format and not in the hard file, we are prepared to provide a CD of our relevant electronic files. We are in the process of gathering the relevant e-mails, telephone logs, and notes, all of which will be placed chronologically in the related hard files. We expect to have all of the above available for review by February 4, 2005.

Comments in response to the numbered items:

5. and 6. The reviewer of the SWPPP was Ryan Lodge. Mr. Lodge left state employment in October 2003 and we are unable to say with any certainty which documents formed the basis for the referenced statements.
