**Violations Listing**

Staff uses the California Integrated Water Quality System (CIWQS) to track Water Board data, including violations and enforcement actions. Attachment 1 is a CIWQS list of violations that occurred between June 1, 2010, and August 31, 2010. CIWQS has a sewer system overflow (SSO) module which provides tracking and reporting of such spills.
