NOTICE OF PUBLIC HEARING

To Consider Adoption of a Total Maximum Daily Load for Chlorpyrifos in the San Antonio Creek Watershed, Santa Barbara County

The California Regional Water Quality Control Board Central Coast Region (Central Coast Water Board) will hold a public hearing to consider approval of a resolution to adopt a Total Maximum Daily Load (TMDL) for Chlorpyrifos in the San Antonio Creek Watershed (Resolution R3-2012-0019).

The purpose of the TMDL is to protect waters within the San Antonio Creek Watershed from water quality degradation due to elevated levels of chlorpyrifos. The resolution proposes numeric targets to protect beneficial uses, assigns allocations to achieve the numeric targets, and outlines an implementation and monitoring plan to gauge the success of achieving the TMDL. Components of the TMDLs are written in the Project Report.

Interested persons may attend and orally comment at the hearing to consider the proposed resolution to adopt a TMDL for Chlorpyrifos in the San Antonio Creek Watershed. Oral comments should be brief (less than 3 minutes) to allow all interested persons time to be heard and should summarize written comments that have been submitted. The Central Coast Water Board may consider this item at any time during the meeting.

Persons wishing to comment on the proposed resolution to adopt a TMDL for Chlorpyrifos in the San Antonio Creek Watershed must submit comments in writing to the Central Coast Water Board at its office in San Luis Obispo no later than **March 26, 2012**. Late comments will not be accepted into the record unless approved by the Chair.
