Executive Officer Briggs introduced staff and State Board Liaison, Jerry Secundy. Mr. Briggs also introduced former Board member, Sig Christierson. He asked all interested parties who wished to comment to fill out testimony cards and submit them. 5. Approval of October 21, 2005 Meeting Minutes......Board Motion

State Board Liaison Jerry Secundy provided an update on State Board activities that covered the Los Osos CSD State Revolving Fund loan status, TMDLs, 303d List for Impaired Water Bodies, 316b Regulations for once-through cooling for

twenty-one California power plants, regulations for on-site septic systems within the State of California, and the Water Quality Coordinating Committee meeting.

Mr. Briggs proposed adding Item #10/Pajaro River Nitrate TMDL to the proposed consent calendar.

MOTION: Les Bowker moved to approve items 10, 18, 19, 20, 23, 24, and 25 for the consent calendar.

Water Board Staff Engineer Larry Harlan presented the proposed Basin Plan amendment that would establish sediment TMDLs and a land disturbance prohibition. Mr. Harlan summarized the various sediment sources, described the numeric targets, and outlined the TMDL implementation plan. The implementation plan included a new land disturbance prohibition for the control of nonpoint sources. Mr. Harlan and Senior Water Board staff member Lisa McCann addressed Board comments regarding sand and gravel mining, the issuing of permits, and TMDL implementation activities and schedules. Board member Daniel Press specifically expressed concern that the numeric targets may not be protective enough and questioned staff about the

values proposed. Executive Office Briggs pointed out that the end result of land use practices (and our expectations of the management plans) would not be different with slightly adjusted numeric Staff member Amanda Bern addressed targets. comments regarding agricultural Board implementation activities and staff member Donette Dunaway addressed Board comments regarding municipal storm water permits.

David Drury of the Santa Clara Valley Water District and Mary Ellen Dick of the San Benito and Santa Clara Valley Farm Bureau provided supported that comment recommendation to adopt the Basin Plan amendment.

MOTION: Gary Shallcross moved to approve Resolution No. R3-2005-0132.

SECOND: Russell Jeffries CARRIED: Unanimously (7-0)

Staff Environmental Scientist Amanda Bern presented information about the importance of technical assistance agencies in implementing farm management practices, and discussed some challenges to implementation. Emily Hanson, Kay Mercer, Kirk Schmidt, Dawn Mathes, and Karen Christianson each voiced concerns with State Board's GPS requirement for all new grants. The individual speakers expressed that the GPS requirement will preclude offering technical assistance, particularly from the Resource Conservation Districts and the Natural Resources Conservation Service, to growers due to their confidentiality policy of disclosing project locations. Speakers commented that there is already a lack of technical assistance providers available to growers, and this new GPS

requirement further decreases funding for staff. The speakers thanked Regional Board staff for supporting industry on the GPS issue. They also thanked Roger Briggs for the memo sent to State Board, which asked for relief from, and proposed alternatives to the GPS requirement, while still addressing concerns about the use accountability of public funds. Some of the speakers indicated that, after discussing this issue for seven months with State Board staff, the State Board was still not receptive to removing the GPS requirement. Dawn Mathes and Emily Hanson asked the Regional Board members to stay informed and become part of the decision making process to influence the State Board on the GPS requirement issue.

21. Monarch Grove Homeowners Association, San Luis Obispo CountyOrder No. R3-2005-0090

Water Board staff, Sorrel Marks, summarized the staff report and recommendations resulting from the October 6, 2005 panel hearing regarding the proposed Administrative Civil Liability (ACL) Order. Ms. Marks also summarized supplemental information regarding a proposed Supplemental Environmental Project (SEP) to be funded by a portion of the assessed penalty. The SEP is expansion of an existing Mutt Mitt program, which provides refuse collection gloves and waste bins at public access points surrounding Morro Bay Estuary. The program has been successful for several years and would be continued and expanded with the use of SEP funds.

Board counsel Lori Okun recommended deletion of a redundant sentence (last sentence of first page of supplemental sheet). Sandra Beebe, manager of the Mutt Mitt program, described the program's current and future activities and answered questions regarding the efficiency of on-the-ground implementation (virtually no overhead). The National Estuary Program provides oversight and funding is handled by the Bay Foundation. Monarch Grove Homeowner's Association attorney, Saro Rizzo, and Director, Jim Wilson, requested reduction of the recommended penalty. Mr. Wilson also assured the Board that the treatment plant is inspected frequently. Martin Bragg, Monarch Grove resident addressed the Board, saying he appreciated the work of the staff and the Board on this issue.

The proposed ACL Order was adopted unanimously by the Board, incorporating the Mutt Mitt Supplemental Environmental Project, with the correction recommended by Lori Okun, and adding annual reporting of SEP activities.
