8. Site Cleanup Program Update Greg Bishop, 805/549-3132, Greg.Bishop@waterboards.ca.gov]

Site Cleanup Program Manager Greg Bishop provided an overview of how the Site Cleanup Program operates, requires dischargers to conduct investigation and remediation, discussed various investigation and remediation techniques, how cases are prioritized for cleanup efforts, and funding options that are available to address pollutants in soil, soil gas, and groundwater.

9. Perfluoroalkyl Substances (PFAS) – Emerging Issue [Greg Bishop, 805/549-3132, Greg.Bishop@waterboards.ca.gov]

A presentation and discussion on perflouroalkyl substances was postponed to a future board meeting at the request of the state water board.

10. CAL FIRE Priority Fuel Reduction Projects in the Central Coast Region [Alexandra Coblentz, 805/542-4786, <u>Alexandra Coblentz@Waterboards.ca.gov</u>]

This was an informational item on Central Coast Water Board staff's involvement with CAL FIRE Priority Fuel Reduction Projects in the Central Coast Region. Staff discussed the Governor's Wildfire State of Emergency Proclamation that initiated immediate implementation of fuel reduction projects for wildfire prevention and described Best

Management Practices to prevent and minimize water quality impacts during fuel reduction activities. Staff clarified that fuel reduction activities in the Central Coast Region is primarily vegetation removal conducted by hand crews, and no work will intersect waterbodies.

- 11. California Water Resiliency Portfolio (Executive Order N-10-19) [Dorene D'Adamo, 916/641-5609, Dorene.Dadamo@waterboards.ca.gov]

State water board liaison to the central coast water board, Dorene D'Adamo, provided an overview of the nature of and need for the Governor's Executive Order N-10-19 to develop a water resiliency portfolio in response to climate change induced variability in water resources due to drought, extreme storm events and flooding, aging water supply infrastructure, and increased demand associated with a growing population and economy. Ms. D'Adamo then discussed the Executive Order's nexus to the water board's existing priorities (e.g., flood control, water supply augmentation, safe and affordable drinking, aquatic habitat and species protection, etc.) and its directive to inventory and assess state and local water supply systems and integrated infrastructure and agreements necessary to develop a water supply certainty plan with an emphasis on how the State and regional water boards can better coordinate and improve water management efficiency based on core principles. Ms. D'Adamo then posed a series of questions to the regional water board to stimulate a conversation about its role in the process and solicit recommendations. Regional water board members subsequently provided comments associated with improved coordination between the Division of Drinking water and the regions to prioritize recycled water projects; the availability of and science and policy supporting brine disposal for both coastal and inland advanced potable reuse projects, and better coordination with the Coastal Commission to maintain coastal outfalls; addressing salt and nutrient management planning deficiencies of the Recycled Water Policy; and formal engagement with the regional boards for the implementation of the Sustainable Groundwater Management Act (SGMA) to better facilitate water quality protection, regional monitoring and permitting of groundwater sustainability plan projects.

Educational Field Trip

15. Montecito Debris Flow Recovery

The tour group will meet in front of the Planning & Development Hearing Room at 9:00 a.m. – 1st Floor, 105 E. Anapamu Street, Santa Barbara. The vans left promptly at 9:15 a.m. the Present

Board members, staff, and stakeholders participated in a field trip to several locations impacted by the Montecito debris flow that followed the Thomas Fire. The first location visited was a debris basin on San Ysidro Creek, which exhibited impacts to the creek from the debris flow, as well as work being done to maintain debris basins. At this location, staff provided a summary of the Central Coast Water Board's regulatory involvement during and after the emergency. Santa Barbara County Flood Control District staff described the work the agency conducted in response to the debris flow. The second site visited was a location further downstream on San Ysidro Creek. This site demonstrated the condition of a cleaned-out creek channel and is also the location of the newly planned Randall Road

debris basin. The final stop was at Goleta Beach, where material excavated during the emergency was placed in the surf zone. At each field trip stop, Board members, staff, and stakeholders discussed various topics related to the debris flow and its management.
