- 5. Report by State Water Resources Control Board Liaison [Sean Maguire, 916/341-5877, Sean.Maguire@waterboards.ca.gov]

Mr. Maguire provided updates regarding the drought and State Water Board's adoption of emergency water conservation regulations; improved water system use reporting requirements to provide more timely evaluation of statewide water conservation efforts; forthcoming State Water Board information item regarding

Strategy to Optimize Resource Management of Stormwater (STORMS) program update; forthcoming updates to the statewide Cal-Trans stormwater, construction stormwater, industrial stormwater, and municipal separate storm sewer system general order updates; statewide large habitat restoration order; harmful algal bloom monitoring and assessment, outreach and education, and research regarding management of nitrogen and phosphorus to prevent harmful algal blooms; ocean acidification and hypoxia related issues, and coordination with the Southern California Coastal Water Research Project (SCCWRP); release of second annual drinking water needs assessment; and, the budget.

Vice Chair Wolff, and Chair Gray engaged with Mr. Maguire regarding funding opportunities and engagement at the regional level regarding projects, priorities and needs; section 8 of the Governor's recent Executive Order regarding the unlawful use of water; need for comprehensive approach addressing the drought; messaging of stormwater as a valuable resource; and, interest in outcome of forthcoming wastewater needs assessment and how it will be applied at the regional with respect to climate change risks and vulnerabilities, and available funding to build capacity and implement projects at the local level.

 Proposed Designation of Chumash Heritage National Marine Sanctuary – Process Overview and Update by Paul Michel, Regional Policy Coordinator, NOAA Sanctuaries West Coast Region [Matthew Keeling, Executive Officer, 805/549-3140, <u>Matt.Keeling@waterboards.ca.gov</u>]

Paul Michel, Regional Policy Coordinator for the National Oceanic and Atmospheric Administrative (NOAA) Sanctuaries West Coast Region, gave an overview of the national marine sanctuary program and the proposed designation of the Chumash Heritage National Marine Sanctuary. Vice Chair Wolff, Chair Gray and members Hunter and Harlan engaged with Mr. Michel regarding: fisheries; green energy and associated infrastructure projects within marine sanctuaries; permitting of advanced water treatment system discharges into sanctuaries; outreach and education; anticipated opposition from fisheries industry; relationships between sanctuaries, marine protected areas, and fisheries management; water quality alliance and coordination with various programs, stakeholders and coalitions; performance monitoring and opportunities to measure carbon sequestration and ocean acidification; and, aquiculture.

7. Consideration of Proposed Order No. R3-2022-0029, Waste Discharge Requirements and NPDES Permit No. CA0047881 for Morro Bay Water Reclamation Facility, San Luis Obispo County [Peter von Langen, Engineering Geologist, 805/549-3688, Peter.vonLangen@waterboards.ca.gov]

Mr. Keeling introduced the item and noted the availability of a supplemental sheet proposing two minor administrative changes to the proposed order. Central Coast Water Board staff geologist Dr. Peter von Langen gave a presentation summarizing the staff report and proposed order, including the proposed changes outlined in the supplemental sheet. Board members engaged with Water Board and city staff regarding ocean discharge monitoring for brine and salinity, and how it relates to the State Water Board's desalination policy; length of the ocean outfall; pathogen monitoring and triggers; facility design to handle fluctuations in flow volume; saline waste production; biosolids production; implementation of recycled water plan; and, funding alternatives pursued.
