Waste Discharge Requirements

7. Consideration of Proposed Order R3-2025-0008, Waste Discharge Requirements and Water Reclamation Requirements for the Monterey One Water, Pure Water Monterey Groundwater Replenishment Project. Presented by, Rachel Hohn, Engineering Geologist, Rachel.Hohn@waterboards.ca.gov, Kristina Olmos, Water Resource Control Engineer, Kristina.Olmos@waterboards.ca.gov, and Leah Lemoine, Senior Water Resource Control Engineer Leah.Lemoine@waterboards.ca.gov

This item began with a staff presentation by Kristina Olmos and Rachel Hohn which included an overview of the Pure Water Monterey project, discussion of regulatory and permitting framework, compliance snapshot, and a summary of public outreach. The Board Members asked questions on the topics of availability of water quality data, frequency of monitoring, ability of the facility to manage extreme weather events, cybersecurity, redundancy of injection wells, and water affordability. Staff answered Board Members questions throughout and following the presentation.

Paul Sciuto, Monterey One Water General Manager, provided a 3-minute public comment expressing support for permit adoption. Paul Sciuto fielded questions from Board Members during and after his comment.

Enforcement

8. Tamara Anderson, Supervising Water Resource Control Engineer, Tamara.Anderson@waterboards.ca.gov presented the quarterly Enforcement Report summarizing actions taken between April 1 and July 31, 2025. The actions included Administrative Civil Liability Orders addressing effluent-limit violations at multiple wastewater facilities, and Expedited Payment Program letters issued to several facilities across the region. The Report included a Time Schedule Order issued to the City of Greenfield Wastewater Treatment Facility to implement phased upgrades and pursue funding through the Division of Financial Assistance. Notices of Violation were also issued across programs. Angela Schroeter, Assistant Executive Officer Angela.Schroeter@waterboards.ca.gov and Tamara Anderson noted that enforcement efforts continue to prioritize violations impacting water quality, human health, and underrepresented communities.

<u>Discussion/Informational Items</u>

9. State Water Board Division of Water Quality Assistant Deputy Director, State Water Resources Control Board Division of Water Quality Annalisa Kihara Annalisa.Kihara@waterboards.ca.gov and Supervising Engineering Geologist Erica Kalve, Erica.Kalve@Waterboards.ca.gov presented an overview on the development of the Statewide Wastewater Needs Assessment (WWNA) a four year project initiated in 2023 to identify and address inadequate or at-risk wastewater systems across California. Erica Kalve and Annalisa Kihara described Phase 1 accomplishments, development of baseline data, methods to assess risk and identification of data gaps. Phase 2 aims to refine cost estimates, identify solutions and develop technical and funding roadmaps through 2027. The presentation emphasized focus on advancing the human right to water and support for underrepresented communities.

10. Executive Officer's Report: Executive Officer, Ryan Lodge,

Ryan.Lodge@waterboards.ca.gov provided updates on regional priorities and initiatives. He discussed the Central Coast Water Board's Strategic Plan for fiscal year 2024-2025, highlighting workforce planning, core program functions, climate adaption, environmental justice and program accomplishments. The next section of the executive officer's report covered updates on the Hacienda Apartments Septic-to-Sewer Project near Soledad, a high priority wastewater consolidation and small community sewer project. Executive Officer Lodge noted that the State Water Board's Division of Financial Assistance offers funding resources and data tools to assist with small community sewer and wastewater projects like Hacienda.

Ryan Lodge concluded his report by stating that the California Attorney General has filed a lawsuit against Sable Offshore Corp following a Central Coast Water Board enforcement referral. The case involves failure to comply with an investigative order and unauthorized discharges of waste to waters of the state.

The following individuals provided public comment. Commentors thanked the Board and urged continued accountability and oversight to protect the Gaviota Coast.
