NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board, Central Coast Region (Central Coast Water Board) will accept public comments on the tentative National Pollutant Discharge Elimination System (NPDES) permit and tentative Clean Water Act Section 401 Certification and hold a public hearing to propose adoption of the order and certification. The tentative NPDES permit and tentative certification include new and updated requirements for Pacific Gas and Electric Company's (PG&E) continued operation of the Diablo Canyon Power Plant, a nuclear electric power generation facility in Avila Beach, San Luis Obispo County. The Central Coast Water Board currently regulates the power plant's discharges under Order 90-09, NPDES Permit CA0003751. The power plant is permitted to discharge up to 2.76 billion gallons a day of wastewater, consisting primarily of steam generation cooling water to Diablo Cove, Pacific Ocean.

All comments received by that date will be considered in the formulation of staff recommendations regarding the NPDES permit and certification. The Central Coast Water Board will not accept written comments or other written submittals on the tentative NPDES permit or tentative certification after 5:00 PM on **December 8, 2025**, unless the chair of the Central Coast Water Board rules that exclusion would create a hardship and that the late submission will not prejudice any party or the Central Coast Water Board. Any person submitting late comments or other submittals must explain why such materials were not submitted by 5:00 PM on **December 8, 2025**. The chair of the Central Coast Water Board will rule on late submittals at or before the hearing. Late submittals that consist of evidence (as opposed to policy statements or comments) are generally prejudicial unless all parties and Central Coast Water Board staff have time to consider the evidence before the hearing.

The Central Coast Water Board will hold a public hearing on **February 26-27, 2026**, to consider the issuance of the tentative NPDES permit and tentative certification at the following location:
