Some examples of the types of information relevant to TMDL development for the Pajaro Basin are **listed below**. *Note: we currently **do** have all data and information that were submitted to the Water Board's **CCAMP** program; data submitted in support of the **Clean Water Act section 303(d) assessment** process; or data submitted to the California Environmental Data Exchange Network (**CEDEN**)*

...examples of information that could support nutrient TMDL development in the Pajaro Basin:

Relevant scientific literature-technical reports or information...

- **Aquatic biological resources in watershed**
- **Water quality data (surface or groundwater)**
- **Photos**
- **Water management in the watershed**
- **Nutrient, Pesticide & Irrigation Management (general info)**
- **Success stories or improvements in land management practices**
- **Watershed studies, pilot studies, grant projects**
- **Etc., anything you think would be helpful or relevant**

If you choose to submit information in support of TMDL development, Water Board staff would appreciate receiving it by **August 30, 2013**. You may submit information to lead staff person Pete Osmolovsky at the email or postal mail contacts shown below. You may also contact Pete at any time if you have questions or wish to discuss TMDL development.
