### **ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; BRUCE ROAD ASSOCIATES, LP, STONEGATE PROJECT (WDID NO. 5A04CR00281A1), BUTTE COUNTY**

This Order responds to the 10 May 2023 request for an amendment to the Bruce Road Associates, LP, Stonegate Project Section 401 Water Quality Certification (WDID No. 5A04CR00281).
