**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; SERRANO ASSOCIATES, LLC,
SERRANO VILLAGE A SEWER LINE PROJECT (WDID#5A09CR00235A1), EL
DORADO COUNTY**

This Order responds to the 28 November 2023 request for an amendment of the Serrano Village A Sewer Line Project (Project) Section 401 Water Quality Certification (WDID#5A09CR00235). The original Water Quality Certification (Certification) was issued on 8 November 2023. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Serrano Associates, LLC is requesting an amendment to the Avoidance and Minimization section to reflect the activities of the Project more accurately. Avoidance and minimization measures taken from the Biological Resources Assessment reference a 2.38-acre "Study Area" that is much larger than the actual 0.267-acre Project site.

The Avoidance and Minimization section references to "Study Area" is amended to reflect the 0.267-acre Project site.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$2,734.00 for the original Certification were received on 17 October 2023. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category E - Low Impact Discharges (fee code 87) with the dredge and fill fee calculator.
