### **ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; COUNTY OF GLENN, ORD BEND BOAT LAUNCH FACILITY ROUTINE MAINTENANCE PROJECT (WDID NO. 5A11CR00033A1), GLENN COUNTY**

This Order responds to the 28 September 2023 request for an amendment to the County of Glenn, Ord Bend Boat Launch Facility Routine Maintenance Project Section 401 Water Quality Certification (WDID No. 5A11CR00033). The original Water Quality Certification was issued on 22 April 2019 and an amendment to modify the project description was issued on 1 September 2020 (WDID No. 5A11CR00033A1). The requested amendment is hereby approved. The original Certification and previously approved amendment are therefore amended as described below. Please attach this document to the original Certification.

#### **AMENDMENT:**

The County of Glenn (hereinafter Permittee) is requesting an amendment to the Section 401 Water Quality Certification and Order to extend the original expiration date of 22 April 2024 by 5 years. The request has been approved and the expiration date of the Section 401 Water Quality Certification is **extended to 22 April 2029**.
