ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER; BHT II NORTHERN CAL 1, LLC, PLACER VINEYARDS 14TH STREET, A STREET, EAST TOWN CENTER DRIVE AND TANWOOD AVENUE PROJECT (INFRASTRUCTURE SEGMENT N), WDID NO. 5A31CR00492A3, PLACER COUNTY

This Order responds to the 29 January 2025 request for an amendment of the Placer Vineyards 14th Street, A Street, East Town Center Drive, and Tanwood Avenue Project (Infrastructure Segment N) Section 401 Water Quality Certification. The original Water Quality Certification (Certification) was issued on 28 May 2019 (WDID No. 5A31CR00492). An amendment was issued on 11 January 2022 (WDID No. 5A31CR00492A1), and a subsequent amendment was issued on 8 May 2024 (WDID No. 5A31CR00492A2). The requested amendment is hereby approved, and the original Water Quality Certification (Certification) and previously approved amendments are therefore amended as described below.
