**ORDER AMENDING NOTICE OF APPLICABILITY COVERAGE UNDER GENERAL ORDER R5-2020-0048, WASTE DISCHARGE REQUIREMENTS AND CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION OF THE WESTERN PLACER COUNTY HABITAT CONSERVATION PROGRAM / NATURAL COMMUNITIES CONSERVATION PLAN PROGRAMMATIC GENERAL PERMIT, PLACER VINEYARDS CENTRAL GROUP, LLC, PLACER VINEYARDS INFRASTRUCTURE SEGMENT M PROJECT (WDID NO. 5A31CR00534-006A1), PLACER COUNTY**

This Order corrects an error in the original Notice of Applicability for coverage under General Order R5-2020-0048, Waste Discharge Requirements and Clean Water Act Section 401 Water Quality Certification of the Western Placer County Habitat Conservation Program / Natural Communities Conservation Plan Programmatic General Permit, Placer Vineyards Central Group, LLC, Placer Vineyards Infrastructure Segment M Project (WDID No. 5A31CR00534-006), issued on 8 February 2022. The original Certification is therefore amended as described below. Please attach this document to the original Certification.
