### **ORDER AMENDING CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION AND ORDER, PLACER VINEYARDS CENTRAL GROUP, LLC, DYER LANE, EASEMENT SEWER, AND PUMP STATION PROJECT (INFRASTRUCTURE SEGMENT D) (WDID NO. 5A31CR00560A1), PLACER COUNTY**

This Order responds to the 2 December 2022 request for an amendment of the Dyer Lane, Easement Sewer, and Pump Station Project (Infrastructure Segment D) Section 401 Water Quality Certification (WDID No. 5A31CR00560). The original Water Quality Certification (Certification) was issued on 22 December 2021. The requested amendment is hereby approved, and the original Certification is therefore amended as described below. Please attach this document to the original Certification.

#### **AMENDMENT:**

Placer Vineyards Central Group, LLC is requesting an amendment to the Certification to align the mitigation credit nomenclature in the Certification with the nomenclature currently used in the context of the Placer County Conservation Program (PCCP). Therefore, Section XIV.K.3; Section XIV, Table 3; and Attachment B, Table 4 are amended in underline format below.

#### **XIV.K. Compensatory Mitigation for Permanent Impacts:**

##### **3. Total Required Compensatory Mitigation**

- a. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.065 acre of Ditch by purchasing 0.098 Aquatic/Wetland credits in the Placer County Conservation Program In-Lieu Fee Program.
- b. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.042 acre of Drainage Canal by purchasing 0.063 Aquatic/Wetland credits in the Placer County Conservation Program In-Lieu Fee Program.

- c. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.005 acre of Ephemeral Drainage by purchasing 0.008 Aquatic/Wetland credits in the Placer County Conservation Program In-Lieu Fee Program.
- d. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.042 acre of Pond by purchasing 0.063 Aquatic/Wetland credits in the Placer County Conservation Program In-Lieu Fee Program.
- e. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.112 acre of Riverine Seasonal Marsh by purchasing 0.168 Aquatic/Wetland credits in the Placer County Conservation Program In-Lieu Fee Program.
- f. The Permittee is required to provide compensatory mitigation for the authorized impact to 0.024 acre of Riverine Seasonal Wetland by purchasing 0.036 Vernal Pool Complex credits in the Placer County Conservation Program In-Lieu Fee Program.
- g. The Permittee is required to provide compensatory mitigation for the authorized impact to 4.715 acres of Seasonal Wetland by purchasing 7.072 Vernal Pool Complex credits in the Placer County Conservation Program In-Lieu Fee Program.
- h. The Permittee is required to provide compensatory mitigation for the authorized impact to 1.589 acre of Vernal Pools by purchasing 2.384 Vernal Pool credits in the Placer County Conservation Program In-Lieu Fee Program.
- i. Total required Project compensatory mitigation information for permanent physical loss of area is summarized in Table 3. [Establishment (Est.), Re-establishment (Re-est.), Rehabilitation (Reh.), Enhancement (Enh.), Preservation (Pres.), Unknown].
