ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; EVERGREEN SIERRA EAST, LLC, COLLEGE PARK, SITE C1 PROJECT (WDID#5A31CR00589A1), PLACER COUNTY

This Order responds to the 1 March 2023 request for an amendment to the College Park, Site C1 Project (Project) Section 401 Water Quality Certification (WDID#5A31CR00589). The original Water Quality Certification (Certification) was issued on 27 February 2023. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please retain this document with the original Certification for your records.

AMENDMENT:

Evergreen Sierra East, LLC is requesting to include an additional 0.069 acre of impacted wetland (seep) in the total permanent direct impacts to waters of the state listed in the Certification issued on 27 February 2023 to be consistent with the United States Army Corps of Engineers (SPK-2017-00078) Clean Water Act Section 404 Permit issued for the Project. The inclusion of the additional impacts to aquatic resources will allow Evergreen Sierra East, LLC to proceed with the Project described in the original Certification.

The Certification is amended to include an additional 0.069 acre of permanent loss of waters of the state, resulting in a total permanent project loss of 0.093 acre of waters of the state (0.008 acre of stream channel and 0.085 acre of wetland).

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$2,734.00 for the original Certification were received on 28 December 2022. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category E - Low Impact Discharges (fee code 87) with the dredge and fill fee calculator.

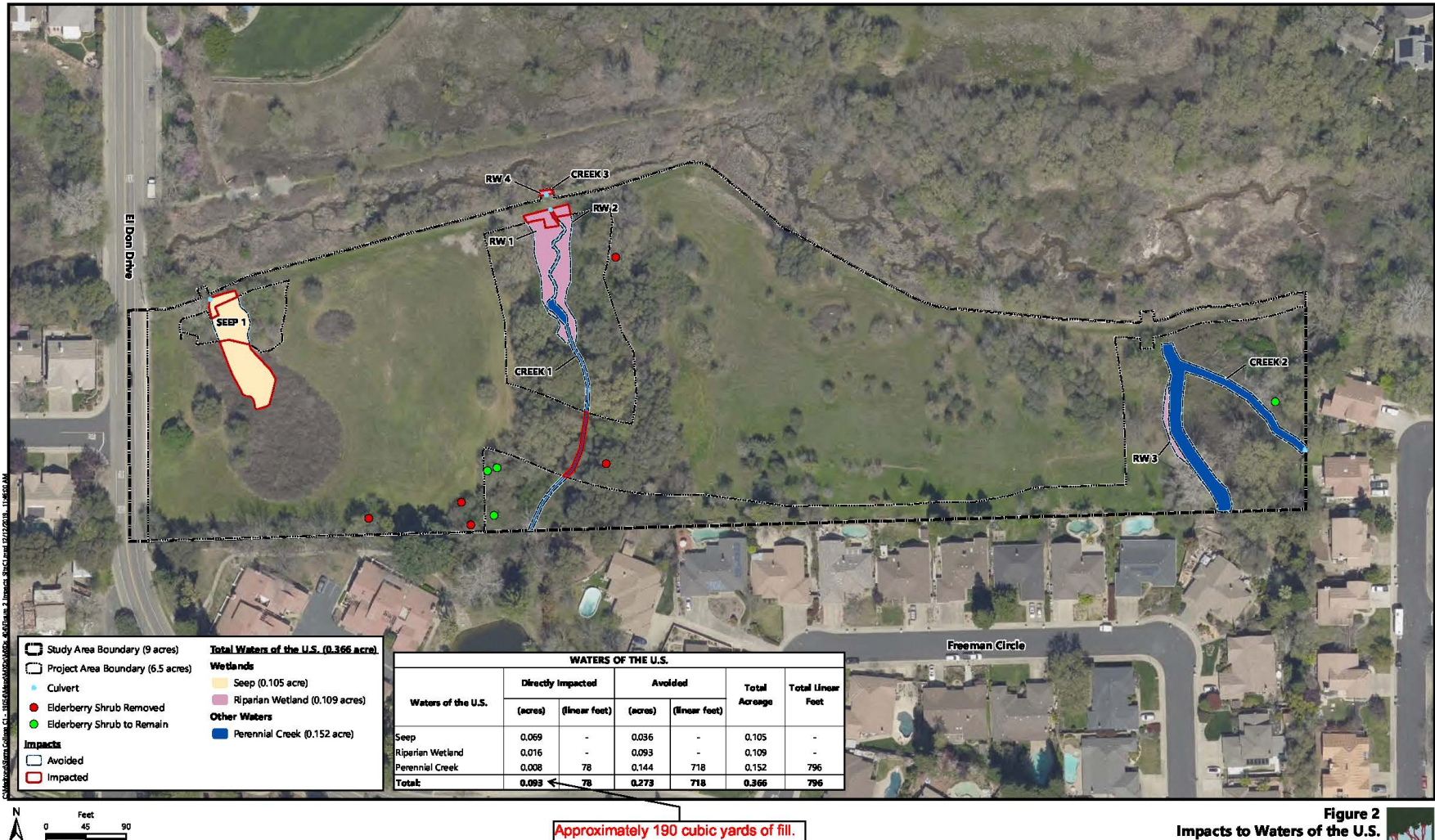
