### **ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; HBT CARPENTER RANCH LLC, CARPENTER RANCH PROJECT (WDID#5A34CR00533A1), SACRAMENTO COUNTY**

This Order responds to the 11 June 2024 request for an amendment of the Carpenter Ranch Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00533). The original Water Quality Certification (Certification) was issued on 11 July 2014. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

#### **AMENDMENT:**

HBT Carpenter Ranch LLC is requesting a time extension through 25 July 2029. HBT Carpenter Ranch LLC has provided documentation from the United States Army Corps of Engineers (SPK-2006-00984) authorizing in-water construction activities to continue until 23 July 2029.

The Certification is amended to authorize in-water construction activities to continue until 23 July 2029.

#### **APPLICATION FEE RECEIVED:**

No fee was required for this amendment. Total fees of \$35,639.00 for the original Certification were received on 7 July 2014. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.

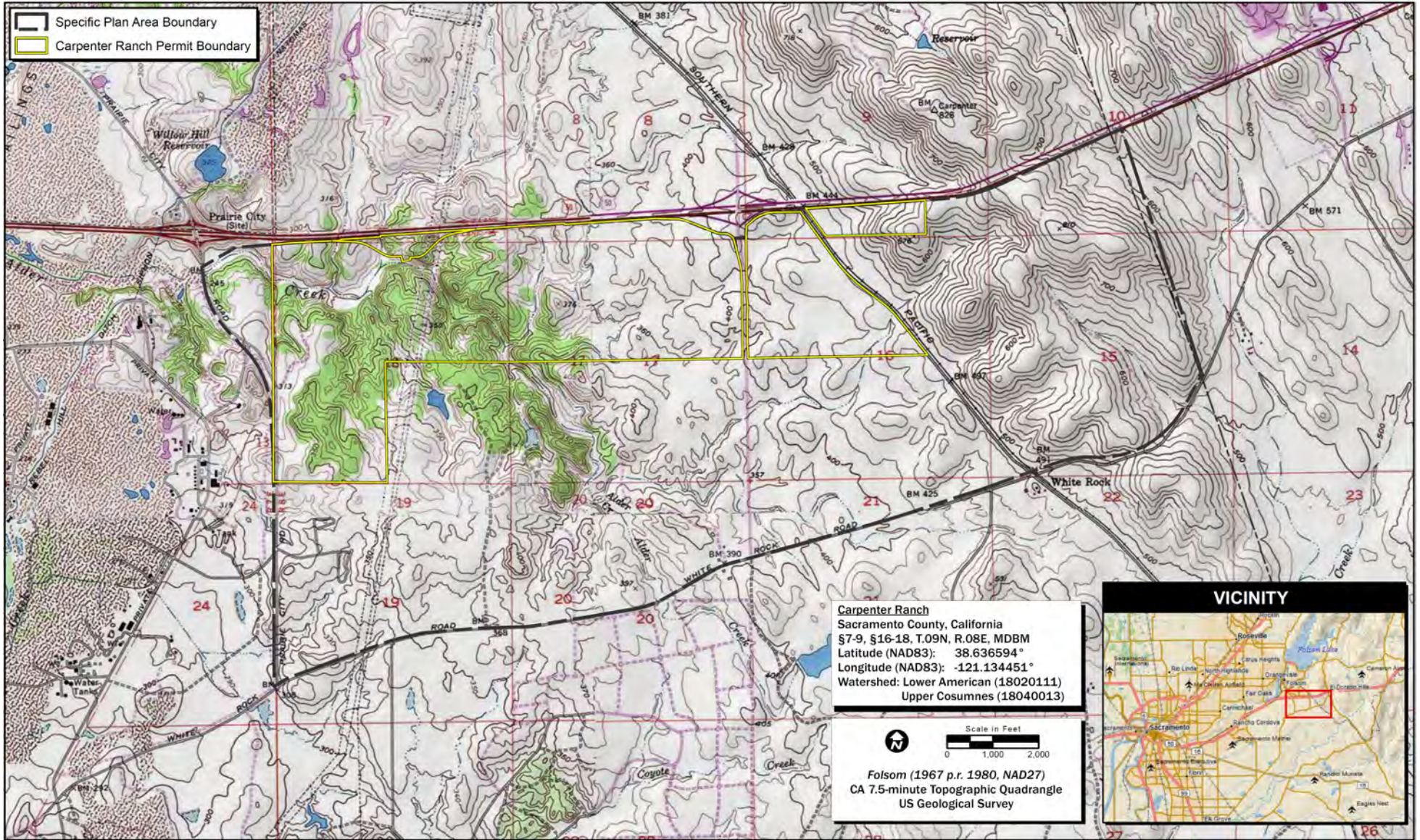




Figure 2: Project Area
