ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; SUNCREEK PROPERTIES, CALLAHAN PROJECT (WDID#5A34CR00618A1), SACRAMENTO COUNTY

This Order responds to the 25 September 2024 request for an amendment of the Kamilos Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00618). The original Water Quality Certification (Certification) was issued on 15 March 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Sun creek Properties is requesting a name change and time extension through 14 March 2029. The name change will allow Sun creek Properties to proceed with the Project described in the original Certification. The Central Valley Regional Water Quality Control Board received confirmation from the United States Army Corps of Engineers on 17 October 2024 that in water construction activities will be authorized to continue until 14 March 2029. Sun creek Properties will provide documentation from the United States Army Corps of Engineers (SPK-2004-00814) authorizing in-water construction activities to continue once the authorization is issued. Sun creek Properties is also requesting to change the name of the project from the Kamilos Project to the Callahan Project.

The Certification is amended to show Sun creek Properties as the Permittee, the project name as the Callahan Project, and to allow in water construction activities to continue until 14 March 2029.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$9,899.00 for the original Certification were received on 26 April 2017. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
