**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; CITY OF SACRAMENTO,
SACRAMENTO MARINA ANNUAL MAINTENANCE DREDGING 2017-2022
PROJECT (WDID#5A34CR00703A1), SACRAMENTO COUNTY**

This Order responds to the 22 June 2021 request for an amendment of the Sacramento Marina Annual Maintenance Dredging 2017-2022 Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00703). The original Water Quality Certification (Certification) was issued on 28 July 2017. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

City of Sacramento is requesting a project description update regarding dredged material placement site location. The update will allow City of Sacramento to proceed with the Project described in the original Certification.

The Certification is amended as shown below:

VII. Description of Direct Impacts to Waters of the State

The maintenance dredging may remove up to a total of 12,500 cubic yards of accumulated sediment from the entrance channel of the Sacramento Marina and the adjacent Miller Park boat ramp area to restore operational depth at the facility over the next five (5) years. The dredged sediment will be removed by clamshell and long reach excavator then placed on an impervious paved asphalt area for dewatering.

Runoff from the placement area will be contained by appropriate methods including wattle or berms so that there is no direct hydraulic connection to land. The placement area will not discharge effluent water to surface waters directly or via a municipal storm sewer system. Erosion control fencing will be installed along the land between the boat ramp and the channel to prevent soil from entering the water. Dewatering is expected to take 30-45 days. After drying, the material may be used for beneficial reuse or disposed of at an appropriate landfill. The disposal of the dredged material is covered under R5-2009-0085-0019.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$720.00 for the original Certification were received on 24 May 2017. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category B - Dredging Discharges (fee code 86) with the dredge and fill fee calculator.
