**ORDER AMENDING GENERAL ORDER NO. R5-2019-0023, WASTE DISCHARGE REQUIREMENTS AND CLEAN WATER ACT SECTION 401 WATER QUALITY CERTIFICATION OF THE SOUTH SACRAMENTO HABITAT CONSERVATION PLAN PROGRAMMATIC GENERAL PERMIT 17 (PGP 17); UNITED STATES DEPARTMENT OF THE ARMY CORPS OF ENGINEERS (WDID#5A34CR00759A1), SACRAMENTO COUNTY**

This Order responds to the 23 February 2024 request for an amendment of General Order No. R5-2019-0023, Waste Discharge Requirements and Clean Water Act Section 401 Water Quality Certification of the South Sacramento Habitat Conservation Plan (SSHCP) Programmatic General Permit (WDID#5A34CR00759). The original General Order was issued on 5 April 2019. The requested amendment is hereby approved. The original General Order is therefore amended as described below. Please attach this document to the original General Order.

**AMENDMENT:**

The United States Department of the Army, Corps of Engineers (USACE), is requesting a time extension of the General Order to coincide with the reissuance of USACE's Programmatic General Permit (PGP) 17: Minimal Impact Covered Activities Under the South Sacramento Habitat Conservation Plan.

The General Order is amended to be valid for the term authorized under the USACE's PGP 17. The General Order is not valid if coverage under the USACE's PGP 17 has expired or been terminated by the USACE.
