**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY  
CONDITIONED WATER QUALITY CERTIFICATION; DEPARTMENT OF WATER  
RESOURCES, SHERMAN ISLAND RESTORATION – PHASE 2 PROJECT  
(WDID#5A34CR00765A1), SACRAMENTO COUNTY**

This Order responds to the 14 June 2024 request for an amendment of the Sherman Island Restoration – Phase 2 Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00765). The original Water Quality Certification (Certification) was issued on 29 May 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

**AMENDMENT:**

The Department of Water Resources is requesting a time extension through 14 March 2026 to coincide with the reissued United States Army Corps of Engineers Nation Wide Permit 27. The Department of Water resources has provided documentation from the United States Army Corps of Engineers (SPK-2013-01084) authorizing in-water construction activities to continue until 14 March 2026.

The Certification is amended to authorize in-water construction activities to continue until 14 March 2026.

**APPLICATION FEE RECEIVED:**

No fee was required for this amendment. Total fees of \$437.00 for the original Certification were received on 2 April 2019. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category D - Ecological Restoration and Enhancement Projects (fee code 85) with the dredge and fill fee calculator.
