ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; CALIFORNIA DEPARTMENT OF TRANSPORTATION COSUMNES RIVER BRIDGE REPLACEMENT AND REHABILITATION PROJECT (WDID#5A34CR00775A1), SACRAMENTO COUNTY

This Order responds to the 11 August 2022 request for an amendment of the Consumnes River Bridge Replacement and Rehabilitation Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00775). The original Water Quality Certification (Certification) was issued on 15 November 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

The California Department of Transportation is requesting an amendment for the incorporation of the new Restoration Plan dated 3 October 2022. Therefore, Section IV.H.1. has been updated.

The Certification is amended as shown below:

Section IV.H.1.

Mitigation for Temporary Impacts

1. The Permittee shall restore all areas of temporary impacts, including Project site upland areas, which could result in a discharge to waters of the state to pre-construction contours and conditions upon completion of construction activities in accordance with the Restoration Plan dated 3 October 2022 and incorporated herein by reference.

APPLICATION FEE RECEIVED:

An amendment fee of \$2,417.00 was received on 28 September 2022. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category G – Amended Orders.
