**NOTICE OF APPLICABILITY; GENERAL SECTION 401 WATER QUALITY CERTIFICATION ORDER REQUIREMENTS FOR THE SACRAMENTO REGIONAL COUNTY SANITATION DISTRICT (REGIONAL SAN), SACRAMENTO REGIONAL COUNTY SANITATION DISTRICT EMERGENCY REPAIR OF POTABLE WATER PIPELINE PROJECT (WDID#5A34CR00787), SACRAMENTO COUNTY**

On 7 January 2020, Regional San (Applicant) filed a notification requesting coverage under the 9 October 2018 State Water Resources Control Board Clean Water Act Section 401 General Water Quality Certification of the United States Army Corps of Engineers (USACE) Regional General Permit 8 (General Certification Order) for the Sacramento Regional County Sanitation District Emergency Repair of Potable Water Pipeline Project (Project). After review of the notification and the supplemental material submitted by the Applicant, the Central Valley Regional Water Quality Control Board (Central Valley Water Board) has determined that the Project qualifies for enrollment under this General Certification Order. The proposed activity took place in 0.002 acre/10 linear feet of waters of the United States.

The Central Valley Water Board is certifying this Project under United States Army Corps of Engineers Regional General Permit 8, Emergency Repair and Protection Activities, subject to the conditions and the notification requirements described in the Nationwide Permit ("Special Conditions"). This Notice of Applicability is being issued under the General Certification Order pursuant to Section 3838 of the California Code of Regulations.

The Project was conducted in accordance with the requirements contained in this Notice of Applicability and General Certification Order. The Project is described in the notification form requesting coverage under the General Certification Order, dated 7 January 2020, and supplementary information (Application Package). Coverage under

the General Certification Order is no longer valid if the Project (as described) is modified.

**PROJECT DESCRIPTION:**

The 0.007-acre Project consisted of fixing an underground potable water pipeline leak. The Project required the excavation and replacement of native soil at the site. The temporarily impacted area was restored to pre-Project conditions by returning the site to the existing grade and hydroseeding with a native plant mix.

The Project temporarily impacted 0.002 acre/10 linear feet of wetland habitat. No dewatering occurred within the Project area. No wet concrete was placed into wetland habitat.

**PROJECT LOCATION:**

The Project is located at Upper Beach Lake in the city of Elk Grove.

Section 18, Township 07 North, Range 05 East, MDB&M

Latitude: 38.45329° N and Longitude: 121.47977° W

**PROJECT SCHEDULE:**

The Project started construction on 30 October 2019 and was completed on 4 November 2019.

**APPLICATION FEE RECEIVED:**

An application fee of \$1,949.00 was received on 7 January 2020.

The fee amount was determined as required by California Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3), and was calculated as category H- Emergency Projects authorized by a Water Board General Order (fee code 85) with the dredge and fill fee calculator.

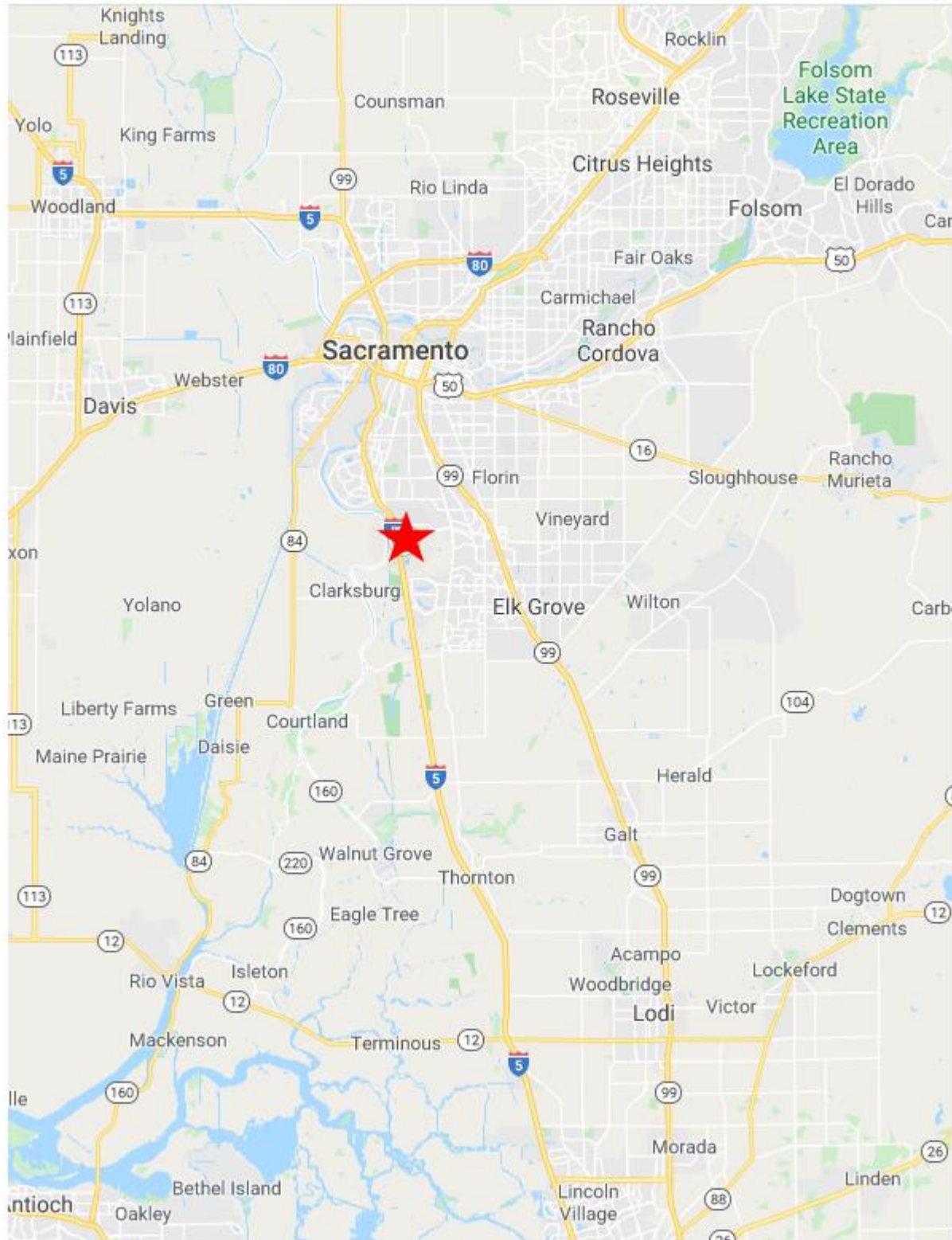

**Figure 1 – Project Location Map**



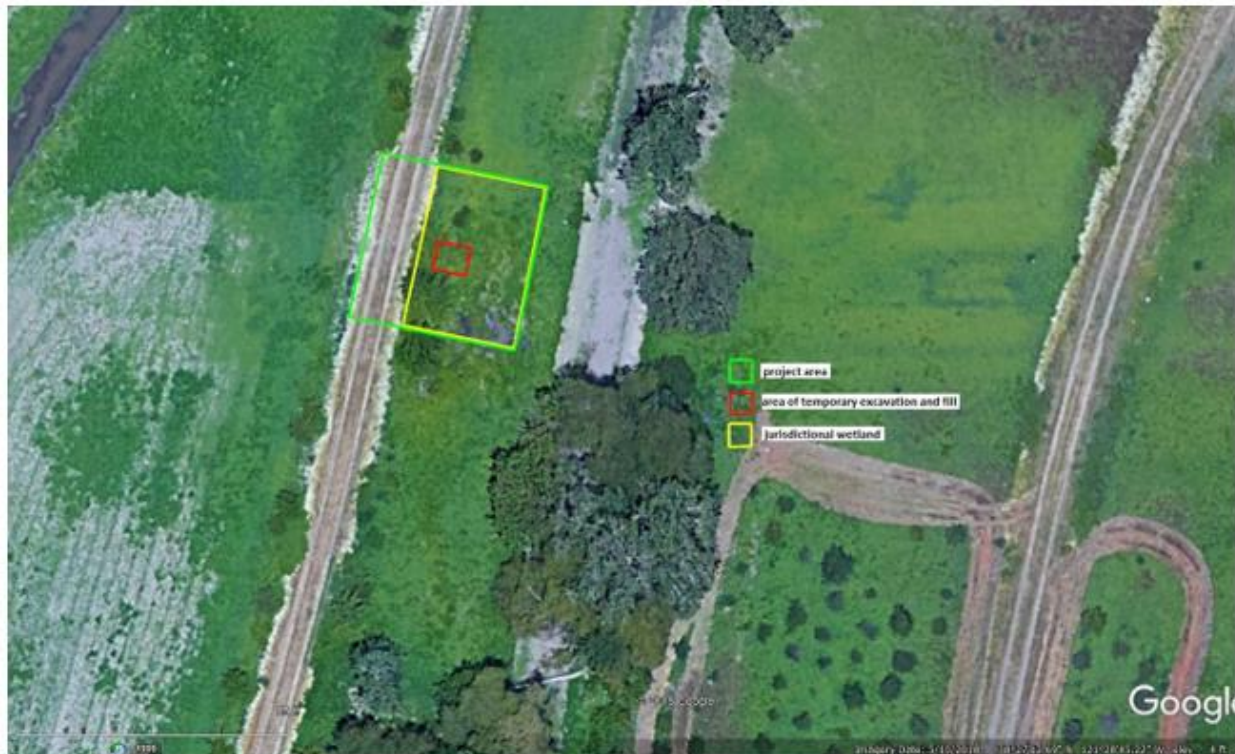


Figure 2 – Site Impact Map
