**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY  
CONDITIONED WATER QUALITY CERTIFICATION; UNITED STATES ARMY  
CORPS OF ENGINEERS, AMERICAN RIVER WATERSHED COMMON FEATURES  
2016 PROJECT, SACRAMENTO RIVER EROSION CONTRACT 2 PROJECT  
(WDID#5A34CR00819-006A1), SACRAMENTO COUNTY**

This Order responds to the 19 December 2022 request for an amendment of the American River Watershed Common Features (ARCF) 2016 Sacramento River Erosion Contract 2 Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00819-006). Figure 1: Project Map Location

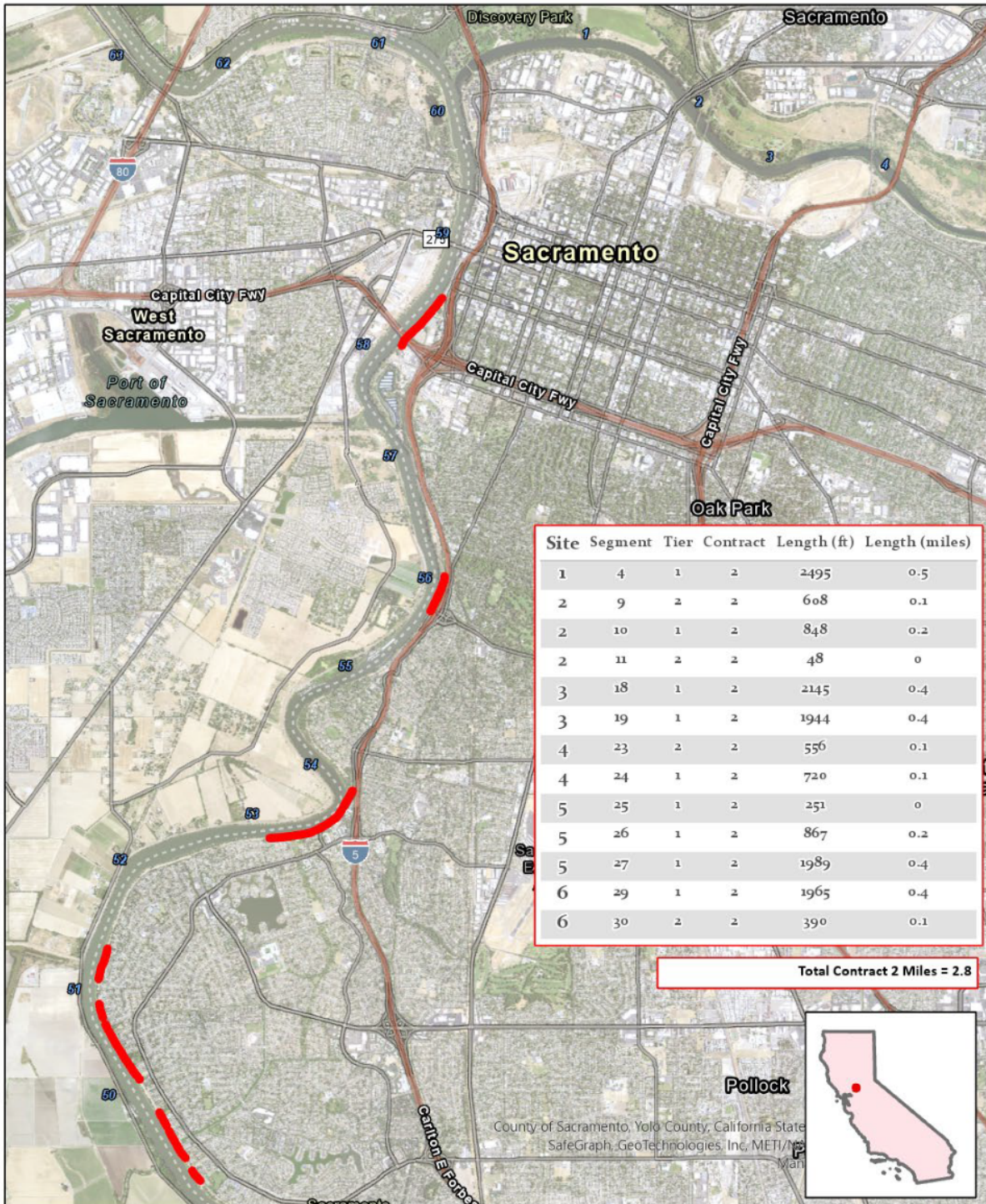
