ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; LENNAR HOMES, SUMMERFIELD AT TWIN CITIES PROJECT (WDID#5A34CR00841A1), SACRAMENTO COUNTY

This Order responds to the 20 March 2024 request for an amendment of the Summerfield at Twin Cities Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00841). The original Water Quality Certification (Certification) was issued on 21 March 2022. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Towne Development of Sacramento is requesting an ownership change. The ownership change will allow Lennar Homes of California to proceed with the Project described in the original Certification. The Certification is amended to allow Lennar Homes of California to proceed as the Permittee in the Certification.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$27,069.00 for the original Certification were received on 17 November 2021. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
