**NOTICE OF APPLICABILITY: STATE WATER RESOURCES CONTROL BOARD
CLEAN WATER ACT SECTION 401 GENERAL WATER QUALITY CERTIFICATION,
SB18054IN, FOR REGIONAL GENERAL PERMIT 8 FOR CITY OF ANDERSON
DEPARTMENT OF PUBLIC WORKS, ANDERSON RIVER PARK BOAT RAMP
EMERGENCY REPAIR PROJECT (WDID NO.5A45CR00623), SHASTA COUNTY**

This letter serves to notify City of Anderson Department of Public Works the Anderson River Park Boat Ramp Emergency Repair Project (Project) conducted under the Army Corps of Engineers Regional General Permit 8 (RGP 8) for repair and protection related activities at the Anderson River Park boat ramp (WDID No. 5A45CR00623) is certified under State Water Resources Control Board Clean Water Act (CWA) Section 401 General Water Quality Certification SB18054IN. This certification is for the purpose described in the Notice of Intent (NOI) and supplemental information submitted by City of Anderson Department of Public Works and is limited to the impacts identified in the application materials.

EMERGENCY WORK DESCRIPTION

The Anderson River Park boat ramp is not currently operational due to the formation of a gravel/sand bar and low flows of the Sacramento River. The current state of the boat ramp impedes use of the boat ramp for search and rescue operations conducted by the Shasta County Sheriff's Department. The Project purpose is to excavate sediment at the inlet of the Anderson River Park boat ramp to allow the Shasta County Sheriff's Department to launch boats to respond to emergencies.

Failure to comply with the terms and conditions of this Certification may expose City of Anderson Department of Public Works to enforcement action pursuant to the Clean Water Act and California Water Code.
