**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; UNION PACIFIC RAILROAD
COMPANY, MILEPOST (MP) 61.39 MARTINEZ SUBDIVISION BRIDGE
REPLACEMENT PROJECT (WDID# 5A48CR00162A1), SOLANO COUNTY**

This Order responds to the 1 August 2023 request for an amendment of the Milepost (MP) 61.39 Martinez Subdivision Bridge Replacement (Project) Section 401 Water Quality Certification (WDID#5A48CR00162). The original Water Quality Certification (Certification) was issued on 24 May 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Union Pacific Railroad Company is requesting a time extension through 16 March 2026. A time extension was authorized by the United States Army Corps of Engineers in January 2022. Union Pacific Railroad Company has provided documentation from the United States Army Corps of Engineers authorizing in-water construction activities to continue until 16 March 2026.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$2,318.00 for the original Certification were received on 14 January 2019. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
