**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; D.R. STEPHENS & COMPANY,
THE FARM AT ALAMO CREEK PROJECT (WDID#5A48CR00164A1), SOLANO
COUNTY**

This Order responds to the 17 October 2023 request for an amendment of the Farm at Alamo Creek Project (Project) Section 401 Water Quality Certification (WDID#5A48CR00164). The original Water Quality Certification (Certification) was issued on 13 August 2019. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

D.R. Stephens & Company is requesting a time extension through 14 March 2027. A time extension was authorized by the United States Army Corps of Engineers on 21 June 2022. D.R. Stephens and Company has provided documentation from the United States Army Corps of Engineers (SPK-2018-00023) authorizing in-water construction activities to continue until 14 March 2027. The original Certification is amended to reflect an updated expiration date of 14 March 2027.

APPLICATION FEE RECEIVED:

No fee was required for this amendment. Total fees of \$28,398.00 for the original Certification were received on 17 May 2019. The fee amount was determined as required by California Code of Regulations, title 23, sections 3383(b)(3) and 2200(a)(3), as was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator.
