**ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY
CONDITIONED WATER QUALITY CERTIFICATION; PACIFIC GAS AND ELECTRIC
COMPANY, GAS LINE 220 CASING REMOVAL AT MILE POST 3.95 (CC-369)
PROJECT (WDID#5A48CR00195A1), SOLANO COUNTY**

This Order responds to the 13 January 2023 request for an amendment of the Gas Line 220 Casing Removal at Mile Post 3.95 (CC-369) Project (Project) Section 401 Water Quality Certification (WDID#5A48CR00195). The original Water Quality Certification (Certification) was issued on 13 January 2023. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

AMENDMENT:

Pacific Gas and Electric Company is requesting an insertion of Wetland impacts on page 4 table 1 for a clerical error.

The Certification is amended as shown below:

VII. Description of Direct Impacts to Waters of the State

The Project is expected to disturb a total of 0.185 acres of wetlands due to excavation and equipment operation. Wetland vegetation is expected to recolonize these sites within one year. All impacts are temporary, and there will be no permanent loss of wetlands or other waters of the state. Total project fill/excavation quantities for all impacts are summarized in Table 1.

¹ Includes only temporary direct impacts to waters of the state and does not include area of temporary disturbance which could result in a discharge to waters of the state. Temporary impacts, by definition, are restored to pre-project conditions and therefore do not include a physical loss of area or degradation of ecological condition.
